Annual meeting of the Parish and Holy Eucharist

Following the Collect of the Day the meeting was called to order.

A motion was made and seconded to accept the minutes of the 2012 Annual Meeting. Motion Passed.

Treasurer's report - Jerry explained the budget vs. actual financial report; we had \$8, 407.99 over budget due to a reduction in expenses after the retirement of Reverend Mary Gustafson and Ray Gustafson, organist. Jerry presented the financial statements for the year ending 2012.

The proposed budget was presented by Susan Howland, incoming treasurer. Susan presented a balanced budget for 2013. Susan explained that with God's help a balanced budget is part of being good stewards. The budget was developed using transparency and realizing that reality is our friend. Questions used when preparing the budget were: how is our money used to further mission grounded in vision? Is mission supporting Christian education? Is there enough income to meet our needs? She said, "With your help and God's help we can continue to be the face and hands of Jesus on Hamilton Street."

A motion was made and seconded to support the 2013 budget, adopted by motion at the January, 2013 vestry meeting.

Sr. Warden's report was a review of the year. Commissioning of the vestry and delegates was done within the Prayers of the People.

MOTIONS 2013

Motions made by the vestry in 2013

Motion made, seconded and carried to accept the December Minutes

Motion made, seconded and carried to adopt a Holy Trinity Church Endowment Policy; policy manual kept in the office

Motion made, seconded and carried to appoint an Endowment Committee Mick Kalber, Jean Frost, and Susan Howland.

Motion made, seconded and carried: To approve the 2013 balanced budget. Part of accepting the budget was to acknowledge the change of job description and salary increase for Chris Bolte who will move from Parish Secretary to Parish Administrative Secretary, and she will now have bookkeeping responsibilities when Jerry Helbig retires and Susan Howland becomes treasurer, assuming election. The budget also reflects a ~2% raise for Ken Bisson and the payroll forms will be filed with the diocese to make these changes.

Motion made, seconded and carried to place \$3,500 in a "Building Reserve Fund" This will be a sub-fund of the checking account to cover approved bills that came in after Jan. 1 for rectory repairs done in Nov. 2012, and money to pay for oil in 2013 from the 2012 budget.

Motion made, seconded and carried to purchase 1250 gallons of oil from CK Smith for a price quote of \$3.48/gal. for an approx cost of \$4,350. Tamsin has been dipping the oil tank since the delivery of 2600 gal. in early September. Through January 6th, we had used 1,374.5 gallons.

Motion made, seconded and carried to make two payments for Church insurance instead of monthly payments to save installment fees. First payment is due Feb 1st.

Motion made, seconded and carried to change Paretti Committee for this interim period to Senior and Junior Wardens and three members appointed by the Vestry, who may or may not be members of the Vestry.

Motion made, seconded and carried to get LeBlanc to do the work that was quoted for (estimate #1302 dated 2/8/13 - \$785) as well as look at downstairs outside spot light and an emergency light for the sanctuary, total not to exceed \$1100.

Motion made, seconded and carried to buy 1000 gallons of oil from CK Smith.

Motion made, seconded and carried to allow Tamsin to draw up a rental agreement with Sharon Palmer for use of Blakely Hall for a six week Yoga class.

Motion made, seconded and carried to grant Hope permission to purchase posters.

Motion made, seconded and carried to move \$300 from line 5221 to 5266, and move \$100 from 5221 to Hospitality budget 5296.

Motion made, seconded and carried to confirm Finance Committee members – Lana Pieczynski, Ed Bair, Tamsin Lucey, Nancy Waugh and Susan Howland.

Motion made, seconded and carried to move forward with sending a proposal to the Standing Committee for selling the rectory.

Motion made, seconded and carried to get a new appraisal of the Rectory by Glenn Bousquet.

Motion made, seconded and carried to preserve the principle of the Watson Fund by using only the quarterly distribution as is done with the other funds. These monies will augment the altar guild budget for the purchase of sacramental wine and vigil lights. Request that the Trustees for the Diocese of Western Mass change the quarterly earnings of the Watson Fund from reinvestment to distribution.

Motion made, seconded and carried to clarify use of monies from Fitzpatrick Fund: Distributions will not be taken from the Fitzpatrick Fund until there is a scholarship to be awarded. Candidates should submit a letter of application to the rector and wardens. Criteria for this award are church membership, need, good character and the desire to better oneself and begin anew, not necessarily previous standards of scholarship. Distributions from the first quarter of the current year and the 2nd, 3rd and 4th quarters of the previous year will be available for the award. If there are no candidates for a particular year then the income will be added to the principal. Request that the Trustees for the Diocese of Western Mass change the quarterly earnings of the Fitzpatrick Fund from distribution to reinvestment.

Motion made, seconded and carried to accept the Holy Trinity Parish Audit Committee's report.

Motion was made, seconded and carried (Susan abstained) to authorize Susan Howland as treasurer of the vestry to sign a contract with Larry Mandel of Caldwell Banker to be the sole agent with exclusive rights to sell the Rectory.

Motion made, seconded and carried to have every vestry member read the CORI Policy for Holy Trinity Church posted on the Zimbra site and Jean will send out an e-mail in 10-14 days for a vote on accepting the policy.

Motion made, seconded and carried to authorize Susan to buy approximately 2850gal oil at the best price she can find at an appropriate time.

Motion made, seconded and carried to hire Tasse's to do the cleaning and repairs on the boilers.

Motion made, seconded and carried to accept quotes from Cole Contracting for flat roof repairs and cracks to archway and wall in balcony.

Motion made, seconded and carried to possibly spend an additional sum to have a structural engineer assess the balcony wall for structural damage.

Motion made, seconded and carried to accept the recommendation of the Search Committee to call Father Richard Signore and leave the logistics to Junior and Senior Warden, Treasurer, the candidate and representatives of the diocese.

Motion made, seconded and carried to sign contract with Tasses to have Burner Boosters installed.

Motion made, seconded and carried to pay Nancy Coderre an additional \$300 requested legal fees for the closing of the rectory sale for a total of \$900 due to increased time and work on our behalf.

Motion made, seconded and carried to accept the bids from Cole Contracting for the Portico restoration for \$7,425 and to repair the columns for \$5,450, with work to start as soon as possible.

Motion made, seconded and carried to transfer \$93,497.50 to the Trustees for the Diocese of Western Massachusetts to establish a Clergy Housing Allowance Fund, the principal to be used as approved by the Standing Committee and the income to be used only to support Clergy housing expenses.

Motion made, seconded and carried to accept the increase of \$6,000 to the estimate for the Portico repair, as it is now a reconstruction, to bring the total to \$13,435 and ask Cole Contracting for a revised estimate.

Motion made, seconded and carried to accept Social Media Policy dated 10/17/13.

Motion made, seconded and carried to follow the Finance committee's recommendation to give Hector and Chris each a \$100 Christmas bonus.

Motion made, seconded and carried to accept the suggested revisions to our Social Media policy.

Motion made, seconded and carried to pay for repairs to the leather diaphragms of the organ from the music fund and unspent organist salary line.

Motion made, seconded and carried to approve a second week of the advertisement in the Southbridge Evening News.

Southbridge Police Association Santa Cop Program is asking for gift certificates to help one particular family.

Motion made, seconded and carried to pay the January rent and a request will be submitted to the Parrettie Committee.

Motion made, seconded and carried to go ahead and have cricket roof repair done as per the quote.

Motion made, seconded and carried to accept the Assessment for Common Ministry as Apportioned by Convention of \$13,998.

ACOLYTE ANNUAL REPORT

The acolytes have been led this year by Christopher A. Briere. Chris began his involvement with the acolytes as part of a GLE (guided learning experience) for a seminary class. Chris created a brochure for the acolytes with information about being an acolyte.

Thanks to the participants who support the acolytes and their role as servant-leaders within HTC: Fr. Richard, Tamsin Lucey, Jean Frost, Chris Briere and guidance from Kurt Frisch, Susan Howland and others.

This year we continue the faith-based sign up for the acolytes introduced in 2012. The intention and program needs to be evaluated for effectiveness. The initial discussions Chris had with some of the parents were encouraging and allowed for family flexibility. We will continue with this approach for the moment. Chris and Jean were able to introduce the concept of having children light the altar candles as a separate function prior to the service. We need to consider monthly statements in the Tidings, bulletins and occasional Sunday announcements on candle lighting and extinguishing as a second phase of faith based servant-leader opportunity. The lighting of the candles led to two new acolyte aspirants Joshua Sanchez and his sister Christina Coran as well as the reintroduction of Robert Ikey, a long time member of HTC. **IT IS IMPORTANT TO NOTE** to all parishioners that we are always seeking youth to help light candles when feasible. We need to consider entering this in Tidings as a way to allow young people to become an integral part of our worship service.

Training occurred before services with discussion after the service over a period of three months. Christina and Joshua achieved first and second torch bearer positions (see leadership guide) while Robert achieved first position.

The training used the “Intention of the acolyte” (see brochure) and the second “The word and light” (candle lighting practice and process) instruction on 1) The robe, 2) Altar elements 3) observation of other functions by Crucifer and church members. We strive to highlight intention in all that we do. We supplemented Scripture readings from 1 Corinthians 3:21 discussion of milk and meat, 1 Corinthians 13-on love is patient and kind, and Ecclesiastes 3 all things in their season.

We gave each person a prayer book for familiarity, a Bible for age appropriate use, and reviewed the Lord’s prayer, creeds and noted the Outline of the Faith in the back of The Book of Common Prayer.

We touched on individual Spiritual growth and understanding of the acolyte as a servant-leader and encourage individuals to step up and fulfill this need within the church. Each person is encouraged to follow the service and participate in reading, singing and assisting the priest with assigned duties.

We should consider an acolyte gathering after Fr. Richard is fully on board so we can clear up any misunderstandings and have a better concept of participants. I need to continue to thank those who by the grace of God have helped us through the year of 2013. Thanks to the following youth and adults who assisted in this way on Sundays, Holy Days, Funerals and Weddings in 2013: Joe DiSalvatore, Kurt Frisch, Jean Frost, Laura Gervais, Tamsin Lucey, Bill, Will & Joe Pieczynski, Robert Ikey, Joshua Sanchez and his sister Christina Coran. Special thanks for those who served as an acolyte in the years past: Nolan Bachand, Cat Reith-Lowry, Rose Reith and Trisha O’Brian-Briere. May God bless and strengthen those who have made an attempt toward this commitment! (Please contact Chris for information to help you in this capacity).

Chris would like to ask all previous acolytes to introduce themselves to him and share with him your best acolyte story. He would like to thank you for serving and to let you know that your contributions have enhanced HTC worship.

2014 Goals

We continue with the following from 2013:

- There was a request for other activity and group opportunities under the acolyte heading which will occur as the population grows.
- There is a need to continue mentoring all ages at all levels and seeking out those opportunities as they make themselves available. (We encourage members to consider lighting and extinguishing candles as a family function and introduction to the servant leader position)
- There is a need for better communication between Family Worship service(s) and the introduction to the Acolyte function.
- There is a constant communication gap and a need to encourage faith based sign up and weekly support of the servant leader position.
- There is question of interlocking a “youth program” to this mentoring program that would enhance church community.
- There is another question of interlocking a youth program to this mentoring program as activities become part of its function.

Future funds: A financial evaluation of the acolyte armamentarium and possible updating of garments should be addressed by the vestry.

We need to consider immediate replacement of Cincture’s in a larger size. An example and cost is available from Jean or Chris.

Further research into cost needs to be assessed and it is believed that kits are available for more reasonable rates.

Short rehearsals were held on the preceding Sunday mornings. The next church musician might want to offer a family choir on occasion, since it was a successful experiment.

Other musical offerings included vocal solos, clarinet pieces by Joe DiSalvatore, and harp music by Susan Howland. As Composer-in-Residence, Dorothy Frisch composed and played in the worship services several communion organ pieces, as well as a seven-section partita and a toccata. Since no organist was available to lead worship for Dec. 29, Fr. Richard organized the parish musicians (three guitarists, harpist, and clarinetist) to lead the music for that Sunday morning.

HOSPITALITY ANNUAL REPORT

Holy Trinity overflows with hospitality, beginning at the entranceway where greeters stand to welcome and direct those who enter here for worship. Once inside there are always members of our congregation who will notice a new person attending and will extend a warm welcome and invite them to join us at "Coffee Time".

Another way that our hospitality is extended is by attending to presenting a pleasant atmosphere along with coffee, tea, juice, and refreshments after special occasions and a calm and comfortable setting after funerals. Those are many of the ways that Holy Trinity expends its hospitality to all who enter here.

There is a large team involved in making all this happen. A pleasant weekly event is our "Coffee Time". There are nine coffee servers, some with partners and some solo. They bring a wonderful variety of sweets, fruit, crackers and cheese, etc. There are sixteen helpers who provide the coffee cream and juice. We have a coffee maker that sets up the coffee urns each week and new this fall, we have added two gentlemen to help with clean-up for those servers that are solo.

Hospitality also extends outside our doors by hosting the "Winter Coat Closet" providing free coats to our neighbors in Southbridge and, at the beginning of the year, serving soup on Tuesday evening to anyone who wished to drop in.

These visits are happy connections, allowing me new understanding of the graces each person brings to the parish; and exploring together as friends, those directions where new life may be found. I have encountered strengths within the family fellowship, and throughout the parish the deep desire to serve Jesus, by the offering of self to God.

I have found in many a strong desire to exercise an active, personal ministry of care. So often it is the laity who carry the greater share of caring outreach. Bravo!!! Parishioners offer mutual support in countless venues. Our Leadership officers set a high priority on tending the short-term needs of people who are homeless, or without food or gas money in the immediate circumstances. Recent efforts involved providing rental assistance to a single mother under extreme financial distress.

These needs often present themselves with a new face, everyday, as often as the parish doors are open! It is an ancient practice of hospitality, receiving the lost and destitute as if receiving Christ Himself. This was the trade mark of all the ancient monastic houses. I am confident that on many occasions we, too, have “entertained angels unawares.”

CHRISTIAN EDUCATION AND NURTURE

FAMILY WORSHIP ANNUAL REPORT

The Christian Formation Team at Holy Trinity Church has continued our new model of ministry for children known as Family Worship. Family Worship takes place during the regular service on the second and fourth Sunday of the month. (Worship times have been changed many times during this year of transition, from 10:15, to 9, to 9:30). Families gather in the sanctuary and are dismissed after the Collect to the parish hall for Family Worship.

The service goes as follows: gathering prayer, Reading of the Gospel, activity, lighting of the candles, Nicene Creed, Prayers of the People, Confession of Sin, closing prayer. We reenter the sanctuary, affectionately called “big church” at the Peace or shortly thereafter. This service allows children and families to worship together, in a kid-friendly way, but also ensures that they receive Holy Eucharist and that the congregation sees and hears children during Sunday worship.

During late summer/early falls the task of leading Family Worship shifted from parents to parishioners. This development came about when Lana Pieczynski and Eileen DeMings demonstrated the difficult nature of trying to parent little ones AND teach a mixed age group of families. It was simply NOT working and something had to be done! At that vestry meeting, we originally asked for a paid assistant to lead, but Mr. Mick Kalber suggested asking parishioners to take turns leading the Family Worship service. We took on the suggestion and three vestry members that very night agreed to lead! Letters were sent to parishioners we felt would be good leaders and the response has been wonderful. There are plenty of Holy Trinity parishioners that have joined us. What once was a burden has become a beautiful relationship between parishioners and families. This new development had revived Family Worship and given parents the support they needed.

We continue to use an online resource for lessons that is part of the Episcopal Church. Lessons for each FW Sunday are prepared by Eileen DeMings and emailed to leaders. Eileen goes over the lesson with the leader if needed. Therefore, a curriculum was not purchased this year, as the lessons are FREE! The lessons are aligned with the Common Lectionary year so families are learning the same Gospel stories as the others in church. We feel this is the core of our Christian Formation strategy- to learn alongside all generations.

Family Worship is a highly support ministry of Holy Trinity Church. We feel that God has called us to the right path of Christian Formation and we will continue to offer Family Worship in 2014. As with any ministry, we will review, revise, and adjust where needed. God has blessed us with many folks that make it happen and for that we are forever grateful.

VACATION BIBLE SCHOOL ANNUAL REPORT

Staff included Holy Trinity parishioners, several from last year. The building was used well this year for VBS. Campers had an opportunity to be in the sanctuary, the parish hall, the undercroft, the backyard and two classrooms downstairs. Lunch was provided to all campers and staff made daily in the undercroft kitchen. A team of parishioners well prepared sets, decorations, and materials before the week started.

VBS was very well supported financially. Parishioners were given the opportunity to contribute in a variety of ways: Sponsorship of a camper, donation of food/snack items, and donation of materials for classes and/or participating in two fundraising events. We had an “Eat at Uno’s night” and a Fourth of July Cookout where all proceeds went to VBS.

Our mission project this year was a food drive for the local food pantry. The campers brought in canned food items into the “Royal Food Court” (Lady Chapel) and proceeded to build a castle out of the cans. The campers had to work together to build a strong castle; tall towers and mighty strongholds without letting the cans topple over. The multi-aged group managed this task with great pride. Over 100 cans of food were distributed.

On the Sunday that followed the end of the VBS week, we held a children’s service. The congregation was treated to VBS theme songs, a children’s sermon and a slideshow. This was a wonderful way to include everyone in the memories we had made all five days and to show the connection between VBS and “everyday” church life.

Vacation Bible School continues to be a ministry that is near and dear to Holy Trinity Church. It is the hope that in 2014 we can host VBS again and perhaps invite other churches to join forces to increase the amount of campers that are able to have the experience of seeing the love of Christ through fun filled summer days. VBS takes a village and we are grateful for all that worked all summer to make it happen.

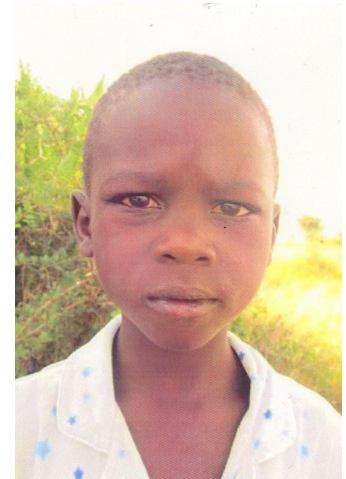

The Winter Coat Closet opened for its seventh season on October 19, 2013. It was staffed by at least two volunteers every Saturday from 9 am until 11 am. Mrs. Sally Baum fulfilled the role again of the weekly volunteer. Mr. Bill Nelson joined the staff as a regular volunteer in November. The Coat Closet is very grateful for their dedicated service.

Each week, volunteers were asked to fill out a report with the following information: number of people served, number of coats given out, number of coats donated, comments and/concerns. According to the data, **200 coats** were given out this season! That is an increase from the previous year.

Advertising was increased this year and the Southbridge Evening News wrote an article about the Winter Coat Closet, thanks to Mr. Mark Ashton. The sign still needs to be replaced, but we decided to wait until the “off season”, as the sign is a major source of advertising.

A change in policy was put into effect this year: **ONE COAT PER PERSON**. It came to our attention that a population was taking advantage of our hospitality and taking too many coats per household. The new policy wards off anyone who is taking coats in excess.

We have a bulletin board in place with information of other local outreach programs and referred those in need

to take a flyer that was appropriate. Since the Bethlehem Lutheran Church has a clothing sale at the Saturday Flea Market located at the former St. Mary's School in Southbridge, we sent any clothing donated there and vice versa if they received coat donations. A worker from Tradewinds in Southbridge made a connection with us and we will try to get a relationship going with that social organization. WARDENS' REPORTS

SENIOR WARDEN'S ANNUAL REPORT

It has truly been my privilege to serve as Senior Warden during 2013. I am amazed at what we have achieved this year. In January 2013, two days before the Annual Meeting, I was stranded (because of snow) at Heathrow Airport, it was total chaos: to my utter amazement a seat was available on a plane that got me back in the USA the day before the Annual Meeting. I knew then that God had "a plan". I had no idea what was in store for Holy Trinity or for me and I can tell you now that I was very apprehensive. I did not know "the plan". What I did know was that God would be with us all the time, that the Holy Spirit would guide us and that we had a good solid vestry, several of whom are previous senior wardens. I also knew that we had some good foundations already laid down: That Nancy Waugh, continuing, as Jr. Warden would be a tremendous resource and Rev. Judith Freeman Clarke as long term supply priest would help guide us through our transition. (Rev Judith remained with us through May) I knew I was, Holy Trinity would be, in good hands.

Just in case you haven't realized, this past year has been very eventful. Your vestry has been kept very busy, for it is they who oversee what happens at Holy Trinity Church. To recap: the Parish Profile Committee completed their appointed task on time and the Search Committee went into action. On behalf of the parish, thank you to all those committee members for your diligent hard work. The vestry accepted the Search Committee's recommendation to call Fr. Richard Signore as our next priest – details of when he will start as our permanent half time priest will be known in early 2014.

Major building work was undertaken at the church this year: repairs to a crack in the balcony wall, window recesses, plaster repairs, the reconstruction of the Portico and repairs to the columns supporting the foyer entrance way. Electrical work was done at the church, updating fire exit signs and emergency lighting, new switches for lights in the parish hall and a working phone jack in the rector's office. Burner Boosters were installed to the both oil burners to improve the boiler efficiency. Dehumidifiers and energy efficient electrical heaters were purchased. The mold situation in the basement is in check, and our secretary and priest no longer have to work in cold rooms. Doors now have signs on them identifying the rooms. The foyer transformation has begun and will be completed at the beginning of 2014. The rectory was successfully sold, with the net proceeds invested to help offset the costs of the clergy housing allowance.

On behalf of the parish, I would like to thank Susan Howland for taking on the tasks of liaison for all the building work and as our representative for the sale of the rectory, both huge responsibilities.

Our sexton, Ken Bisson, of 8 years retired and will be sorely missed. We hired Hector Chapa who is proving to be a huge asset. At the end of the year we also hired Michaela Guy as Child Care Assistant to help with young children of families attending our services. The parish secretary had an annual review and the sexton a 3 month review. There are new rental contracts for monthly rentals and new rental agreements for single use rentals, there is a Social Media Policy and a CORI Policy in place and goals for the parish are being established. We have kept the Website up to date and Facebook postings active. We advertised Christmas services in the newspaper, on line and via Local Access Cable channels, with coordinated art work.

All this and more has been overseen by your vestry. On behalf of the parish, I would like to thank each vestry member, Peg Nelson, Ellen Lincourt, Mick Kalber, Suzy Sharp, Jean Frost, Susan Howland and Nancy Waugh for your diligence, support and hard work this year. Each of you have brought your gifts and talents to the vestry table and shared generously. Holy Trinity is very fortunate and truly blessed to have you on board. On behalf of the parish I also thank each of you for continuing to serve on the vestry in 2014. On behalf of the

vestry I would like to thank all who have served the parish this year, for sharing generously your, gifts, talents and Love of Christ with us and the world.

We are not done yet! In 2014 we will continue to listen intently, discern diligently and with grace and blessing 2014 will see us draw up a Position Description for our rector, celebrate the start of a new mutual ministry with Fr. Richard Signore, form a search committee for an organist/music director, do some repair work to the roof, work on attaining our 1 year goals and put actions in place to achieve our 3 year and 5 year goals. ADMINISTRATIVE AND BUILDING

BUILDING AND GROUNDS STEWARDSHIP TEAM ANNUAL REPORT

In 2011 Holy Trinity changed the Wardens job description; the Jr. and Sr. Wardens became co-wardens, looking after the administrative and pastoral needs of the Parish. Previously the Jr. Warden oversaw building and ground. Since 2011 the vestry as a whole has been overseeing the building and grounds ministry, but this left the building and ground ministry without a point person. This year, with major support from the vestry, the Sr. Warden and Treasurer have executed the building and grounds projects, so we are writing this report.

As promised at the beginning of 2013, the funds not used to cover the expenses of a settled priest and seated organists were used to establish reserve funds and to address pressing building repairs. Because of the faithfulness of the Holy Trinity parishioners combined with the tremendous response to the portico/column restoration project we were able to complete the following:

- Repair a 15-year-old crack in the balcony, and assess the stability of the balcony arch, and church tower tie in.
- Repair the plaster to three window casings in the narthex and balcony, and repair water damage to plaster in the foyer.
- Repair the flat roof above the foyer and make it watertight.
- Restore the portico.
- Restore the foyer entrance columns.
- Repaint both front entranceways.
- Make electrical renovations to bring the church and parish hall fire exits and emergency lighting up to code.
- Purchase two small energy efficient heaters to heat the secretary and rector's offices, so only these small spaces are heated when used mid-week.
- Modify the two boilers to burn fuel more efficiently (Burner Booster Project); we are guaranteed a 15% reduction in oil usage, adjusting for degree-days.
- Purchase dehumidifiers to help address the problem of condensation and mold in basement rooms.
- Started an organ renovation to replace 61 leather diaphragms. This will repair the notes that are not sounding at present, and prevent others from failing. . The organ is part of the building and we must keep it repaired if we want it played.

Additionally Tamsin and Susan worked with our new sexton, Hector Chapa, to make minor repairs and assess the ongoing building needs to ensure Holy Trinity is a safe and welcoming church.

A number of fitness instructors approached us this year about using the Parish Hall and there are now fitness classes held most days of the week: yoga, tai chi, Zumba, and line dancing. Rental agreements have been updated; there are now agreements in place for all ongoing rentals (AA and exercise etc.), and new agreements were drawn up for single use rentals for both the undercroft and parish hall.

Finally, one of the major endeavors of 2013 was selling the rectory. The rectory, built prior to 1890, was in need of over \$25,000 worth of repairs and was a continual drain on parish finances and manpower for upkeep and utilities. The vestry worked diligently to find the best real estate agent and execute the sale; we closed on the sale September 13, 2013. The net proceeds (\$93,497.54) were put in a restricted endowment fund (by diocesan rules) and the income from this endowment will only be used to offset the cost of the clergy housing allowance.

While we have made good use of the funds not needed THIS year for clergy and organist we need to be intentional about how we will continue to maintain our almost 150 year-old church and nearly 50 year-old parish hall. There is still work that needs to be done to the roof, soffit, eaves, brick work, and a window repair, together with repainting the trim to the parish hall and church. It is our hope and prayer that a building and grounds team will form, with full vestry support, to see this dream to fruition within the next 5 years.

PARISH PROFILE COMMITTEE

In the fall of 2012, the Parish Profile Committee was prayerfully called upon to conduct a self-study and create an online document that tells our story- who we are TODAY and who God is calling us to become. This document would contain text, pictures, quotes and images that would be read by potential candidates during the search for our new priest.

Our work began by asking the congregation to complete a survey containing questions from the Office of Transitional Ministry and those questions we felt necessary for own data collection. The data was analyzed by the committee- each member pair studied and presented the finding to the larger group and the data, including quotes was used to write each section of the profile. Those sections included worship styles, demographics of our region, history, current ministries, etc.

During the months of January and February, the committee met several times for editing sessions. Each author presented his or her sections for review. Through spirited discussion, thoughtful insight, conscientious and diligent writing and rewriting (and more rewriting), the document was finalized. The text was then placed in a digital and artful format along with pictures to paint the true story of Holy Trinity Church. The parish profile was submitted to the OTM in March of 2013.

The process was labor intensive, professional, and spiritual and thought provoking. The committee is extremely proud of the parish profile and was very honored to have been a part of the process. The parish profile can be viewed at www.holytrinitysouthbridge.org and hard copies are available on loan from the church office.

FINANCE COMMITTEE ANNUAL REPORT

The finance committee is a committee of advice to the vestry; all decisions made at meetings go to the vestry for their consideration.

The finance committee met three times in 2013. The third meeting was to put together the budget.

During meetings we review the budget vs. actual reports to be sure we are staying within the budget or are intentionally making adjustments. Fund accounting was introduced this year; sub funds of the checking account are utilized to present a realistic picture of what money is available for each ministry area, to reserve funds for yearly bills, and to track restricted funds.

A purchase order form was developed and will be kept in the office and on the church computer. Time sheet were developed to track and document employee hours.

The committee followed the sale of the rectory and received reports from the endowment committee.

The committee has been working on the details of the clergy package.

To develop the 2014 budget we used the parish profile expectations of the Clergy, which also apply to our parish goals and went line by line to see if the expenses were in keeping with our mission priorities.

These thoughts emerged:

- Evangelism and Local outreach should be added as a budget line and funded. Budget items like publicity, intentional secretary time for communication, lay ministry attention to publicity, signs, free ad space in publications, and outreach projects similar to Cops for Kids.
- A few budget lines were renamed or relocated within the budget to better account for/explain these expenses: music, organist.

We set a goal of the end of 2013 to put a Financial Policy in place; a draft is in review at this writing.

The various chairs of ministries were contacted about their budgetary needs with the goal of having the ministry areas oversee their budgets and have spending authority. Financial administration notes were drawn up to identify who has spending authorization over the various budget lines and these notes will be incorporated into the financial policy in a broad way and then used yearly to review the mission driven budget.

ENDOWMENT COMMITTEE ANNUAL REPORT

On January 7, 2013, the vestry adopted Endowment Fund Policies and Guidelines formally establishing a General Endowment Fund for Holy Trinity Church of Southbridge. The existing endowment funds are now included in this Endowment Fund keeping their original intention and restrictions. Two thousand dollars (\$2,000) from a gift of life insurance upon the death of Gertrude Brennan, was used to establish the Holy Trinity Legacy Fund. The Legacy Fund will receive all unrestricted bequests. Income only will be used from this fund for non-operating expenses, "to enable the PARISH to fulfill its mission more completely by developing its ministries beyond what is possible through its annual operating funds. Distributions from the fund therefore shall be limited to: (i) capital improvements of the PARISH; (ii) outreach ministries and grants; (iii) seed money for new ministries and special one-time projects; and (iv) such other purposes as are specifically designated by donors to the PARISH whose gifts are included in the FUND."

The Endowment Fund Policy calls for a 3-member committee to oversee the Endowment Fund. The vestry appointed the following committee: Mick Kalber, chair (3-year term expires 1/2016), Jean Frost, secretary (2-year term expires 1/2015), Susan Howland member (1-year term; term expires 1/2014.) Bill Pieczynski will be appointed for a 3-year term 1/2014.

The committee met once on May 7, 2013, and reviewed the portfolio and the various restrictions to ensure they are being met and made recommendations to the vestry.

The Endowment Committee made three recommendations adopted by the vestry in 2013:

1. The Emeline & George Watson Fund, which is not a true endowment fund, was started with a gift of \$1,500 from George Watson to be used for the purchase of sacramental wine and contributions for the Vigil Light in his wife's memory. Contributions made in memory of Robert Dannies were added to this fund. At the time this gift was given George Watson was aware that the fund would eventually run out of money. In light of this, the Endowment Committee felt it would be possible to preserve the principal by using only the income that is distributed quarterly. A motion was made to preserve the principle of the Watson Fund by using only the quarterly distribution as is done with the other funds. These monies will augment the altar guild budget for the purchase of sacramental wine and vigil lights.
2. The Fitzpatrick Fund distributions will not be taken from the Fitzpatrick Fund until there is a scholarship to be awarded. Candidates should submit a letter of application to the rector and wardens. Criteria for this award are church membership, need, good character and the desire to better oneself and begin anew, not necessarily previous standards of scholarship. Distributions from the first quarter of the current year and the 2nd, 3rd and 4th quarters of the previous year will be available for the award. If there are no candidates for a particular year then the income will be added to the principal. Request that the Trustees for the Diocese of Western Mass change the quarterly earnings of the Fitzpatrick Fund from distribution to reinvestment. The motions were seconded and approved.
3. The Legacy Fund will be reinvested to allow it to grow.

Our portfolio is managed by the Trustee for the Diocese of Western Massachusetts, a corporation that manages the diocesan funds and allows parishes to invest as well. The fund is managed like a mutual fund, uses socially responsible investing practices, and has low management fees. They use a set percentage to distribute income (interest, dividends and capital appreciation) from the fund, which is based on a 12 rolling quarter average. This practice protects investors from the highs and lows of market fluctuation.

On September 30, 2012, our portfolio was \$366, 833.32. On September 30, 2013, our portfolio was \$390, 026.11, an increase of 6.32% The Legacy fund and the Clergy Housing allowance fund were added to the portfolio bringing the total to \$485,576.53. The 4th Quarter reports are not available at this writing.

TREASURERS REPORT

Operating Budget

Income: overall income exceeded the budget by \$7,783.46: Budget: \$123,972.00 Actual: \$131,755.64.

Why?

- Holy Trinity Parishioners are generous!
- Super fundraisers: Yard Sale: Karen Ballou and team; Rice-O-Rama: Hope Wilson and team; Pies, Tamsin Lucey and team; all the VBS angels. \$3, 945.93 total; \$1,945.93 over budget.
- Sale of the rectory allowed us to put the net rectory rental income into the operating budget.
- The checking account was changed into an interest bearing account: \$460.65 in interest for 2013.

Expenses: overall expenses were less than budget by \$28,489.81; not including the money that was spent for capital improvements is 2013. Budget: \$123,972.00. Actual \$92,513.72

Why?

- Music was under budget by \$6,188, because we did not have a seated organist.
- Clergy was under budget by \$25,447.97, because we did not have a settled priest.
- Many other lines were under budget, some because the funds were not needed and others because of frugal spending. (Our Church secretary is a bargain hunter.)
- In addition we did not have to take the budgeted reduction for unpaid pledges, because of people who over paid their pledge.
- The two lines that were over budget:
 - Insurance: \$10, 280 is for two years; the 2013 insurance was paid in 2013 and 2014 insurance was paid by 12/31/13, avoiding \$60 in financing charges.
 - Oil is \$4,903.03 over budget; the oil tank was nearly empty in January 2013, so we had to buy oil for most of the winter, but we should have enough oil for the remainder of the 2013-14 season.

Non-operating Budget

- The un-budgeted capital improvements were \$25,470.90; of that, \$9,615 was received from the Portico fundraiser.
- We were able to recover all the Rectory sale expenses from the gross proceeds: \$97,993.61. The net proceeds from the Rectory sale were \$93,497.54, which was placed in a permanent endowment fund, income only, for clergy housing allowance; income is currently reinvested until needed.
- Parrettie Endowment income was \$6,701.51, and Parrettie request grants were \$7,093.81, in addition to the \$2,400 transferred to the Rector's discretionary fund.
- The Rector's discretionary fund inflow was \$2,400.03, with \$1,748.52 given in alms.
- The mission plate offerings were \$1,787.22, with \$2, 508.19 given: \$720.97 from the 2012 offering.
- \$360 was sent to Childreach/PLAN to sponsor Nicholas in Kenya; \$360 was donated to sponsor him.
- The 2013 United Thank Offering was \$651.
- There were no Fitzpatrick Scholarship requests in 2013; the income is now reinvested until needed.
- \$2,000 of the Brennan gift was used to start the Holy Trinity Legacy Fund.
