Minutes from the Annual Meeting of Holy Trinity Church

The meeting was called to order at 9:40 A.M. by Nancy Waugh. Peg Nelson was named secretary, and she declared a quorum was present. A motion was made, seconded and carried to accept the minutes from the 2016 annual meeting.

The Treasurer's report had been presented at a gathering before the service, and a motion was made to accept the report. It was seconded and carried. Copies of the Statement of Cash Flow and the Statement of Financial Position are attached and made a part of these minutes.

The Budget for 2017, which had been approved and accepted by the Vestry at their January meeting, had also been presented before the service. There was a call for questions regarding the budget. With no questions brought forth, **a motion was made to accept the 2017 budget. It was seconded and carried.** Treasurer Susan Howland explained our practice of year-round stewardship and the process for establishing a budget. Our 2017 balanced budget totals \$125,301 in income and, therefore, \$125,301 in expenses.

The qualifications for elected office were read by Nancy Waugh. The slate of officers, Vestry members and other elected positions was presented on a printed sheet (copy attached to these minutes) and read aloud by Nancy. The floor was opened for nominations.

The service continued with Psalm 15.

After the homily, nominations from the floor were closed. There being none, the Secretary cast a single vote to accept the whole slate as provided.

Nancy thanked Jean Frost for her many years of service to the vestry, and she expressed the hope of the congregation that, after a much deserved break, Jean will return to the vestry. She thanked Peg Nelson for taking the Clerk's position and welcomed Lynn Garland to the vestry. Nancy spoke about building relationships and community and thanked the staff, Anne, Chris and Hector. She expressed regret that Hector will be leaving us on February 4 for a job closer to home. Nancy asked that we recall the Bishop's statement that we double down in prayer as we move forward in mission.

Fr. Richard opened the floor for discussion of any old or new business. There being none, the meeting was adjourned. The service continued with the commissioning of the Vestry and delegates.

February 8, 2017

Motion made to accept the minutes from the January vestry meeting emailed January 31, 2017, seconded and carried. Motion made, seconded and approved to accept the Treasurer's report emailed February 4, 2017. A motion was made, seconded and approved to keep the flower fund balance at \$500. All flower donations will be put into the fund for payment of the flower bills and the \$200 balance will be moved to pay for the pew card project. A motion was made, seconded and approved to accept the John Miller life insurance gift of \$10,000. A motion was made, seconded and approved to close out the Brennan reserve and move \$8,961.29 to the building fund. A motion was made, seconded, approved to accept Anne Bouvier-Monroe's new contract. A motion to accept the Parochial Report as presented was seconded and approved.

March 8, 2017

A motion to accept the minutes from the February vestry meeting emailed February 11, 2017, was seconded and carried. A motion was made, seconded and approved to accept the Treasurer's report. A motion was made, seconded and approved to move \$3,000 from the building fund into the organ fund.

April 8, 2017

On March 30, 2017, Tamsin Lucey emailed the following motion, requiring no second: To pay the sexton (Brian Canty) a starting rate of \$12.50 per hour. Following a review between the 3rd and 6th month to increase the hourly rate to \$13.00. To include in the package 1 week's (11 hours) paid vacation per year, eligible after completing 6 month's employment at a prorated per month rate. The motion was approved by email.

A motion was made, seconded and approved to pay \$250 for half a solar panel for Bethlehem Lutheran Church. A motion was made to move forward on applying for a Congregational Development Grant to help bring the building up to code. Motion seconded and approved.

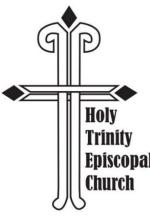

Dear Friends,

The strength of our Parish is best seen in the skills and dedication of parishioners who offer their abilities for the sake of people both within our circle of familiar faces, and those reaching beyond our current membership. Our activities share the Gospel of Love as a matter of faithfulness to Jesus, with the hope others will find a compelling desire to share those tasks. What could be more fun, or even more compelling, than a community gathered in dedicated to the needs and joys of the people we meet. That is a world where the Gospel is lived. That is a world I would choose to live in, for myself and my children.

To enhance this mission, we will:

<u>Liturgy:</u> We have initiated an experiment to allow our liturgy to teach the skills of deepening our appreciation of the presence of God, through reflection on the Scriptures and the use of brief silence. An active, "doing" faith finds its root in the quiet conviction of encounter with God. Apart from one's spiritual center, the tasks are too much to schedule. Centered in God, these same tasks are energizing and life-giving. Listening to God is the essential piece in spiritual journey. To allow this, the liturgy will be adjusted to focus on essentials so as not to distract from the strength from God.

The evaluation of the use of time for our liturgy is of great benefit for all our members as we find the most effective presentation of the faith, within the scope that can be well tolerated by members and new-comers alike, on the pace life is lived today. Being cognizant of pace also helps us build on another strength by encouraging involvement of parents and their young children on Sundays that are not "Family Worship" dates (representing more than a 1/3 of our worshipping congregation).

<u>Bible Study</u> and correlative educational/formation experiences: We have conducted targeted educational program for different age-groups in the Parish (Confirmation classes, 1st Communion classes, seasonal/brief bible studies, sessions for Daughters of the King and Vestry, and individual bible coaching). The main dialogue to deepen understanding of the lived faith happens in the Bible Study shared with Bethlehem Lutheran Church on alternate Wednesday evenings. Now in its third year, the group has come to deeply value the beliefs and experiences of its participants. The discussion represents a significant searching for the work of God within....and has become a rewarding expression of shared community.

<u>Pastoral Care:</u> is an area in which a part-time priest could profitably dedicate all his working hours, and still determine additional care is needed. So we are very grateful for the efforts of everyone! How often members involved in out-reach to other members - and we are very deeply grateful. We wish to note the Ushers (who often deliver flowers from the altar to shut-in or hospitalized individuals) and Laura Gervais - who has taken the sacrament from the altar to certain shut-ins and residents at the Overlook Home in Charlton. Laura has made tremendous efforts. I am grateful for visits made to one-another within the congregation as Christ's Love finds expression in your care and concern. I have tried to prioritize individuals around times of hospitalization and surgery, and major life changes (e.g., entering a nursing home or impending death). Please let me know your needs, by calling directly on my cell phone (617) 281-5183. You may also message concerns through the Wardens if you prefer. By all means, please let us know your needs.

In this vein, we also mention with Thanksgiving the years of service of Bobbie Helbig, as coordinator and chair of the Helping Hands Ministry, which coordinates meals for families in a crises or radical change. Her work has benefited so many families when they most needed help to get over a "bump in the road." We are so thankful for the work she has done. She will need to release the reigns on this ministry as she plans to relocate in her and Gerry's retirement. She will be sorely missed.

Our strength remains, to show the love and care of Jesus Christ, with authentic affection, right here where we are and to whomever Jesus brings to us. With gladness we present each moment back to God as a gift from a loving Church. I remain,

STEWARDSHIP PRAYER TEAM REPORT

"Journey to Generosity" was the theme of our stewardship campaign this year. During a service before our campaign started, Fr. Richard taught us with an interactive sermon. The Rev. John P. Miller: Holy Trinity Rector, Sept. 1959 – Sept. 30,1967



The Rev. John P Miller departed this life peacefully and has entered the Kingdom of Heaven on December 24, 2016; he was 83. John was born February 15, 1933 in Cambridge, MA, He attended high school in Reading, MA, the University of Massachusetts at Amherst, and Episcopal Theological Seminary in Cambridge, earning his Masters of Divinity. He married the love of his life Barbara M. Crouse on September 8, 1956. He served at St. Philip's in Easthampton, MA, Holy Trinity in Southbridge, MA, St. John's in Bangor, ME, and Holy Trinity Episcopal Church in Middletown, CT. He and his wife continued their ministry together at St. Andrew's Episcopal Church in Readfield, and St. Mark's in Waterville after their retirement to Maine. In 2004, John

and Barbara moved to Pawley's Island, SC, where they often served together at Holy Cross/Faith Memorial in Pawley's Island until Barbara's diagnosis of Alzheimer's Disease in 2007. John was devoted to her until her death in 2013. His funeral was held at St. Mark's Episcopal Church, Waterville, ME, on January 28, 2017

Rev. John Miller served Holy Trinity, Southbridge from September 1959 to Sept 30,1967. Although there is not much parish history documenting these years at Holy Trinity it was a time of great societal change:

- 1960 Kennedy elected president
- 1961 first US manned space flight
- 1962 Cuban missile crisis
- 1963 march on Washington: Martin Luther King "I have a dream"
 - o President Kennedy assassinated; Lyndon B. Johnson, president
- 1964 "war on poverty"
 - o Medicare signed into law
- 1965 The Right Rev. John Elbridge Hines elected Presiding Bishop of the Episcopal Church; he commits the church to social justice and helped open its clerical ranks to women and blacks.
- 1966 urban renewal; race riots; anti-war protests

• President Lynden Johnson calls for environmental protection, education for all, and universal healthcare. From the records we do have, these were challenging years for Holy Trinity Church. There were on going building concerns: the fire alarm system replaced last year was installed in 1966. There were budget deficits and continual questioning about how Holy Trinity was fulfilling Christ's mission in the community and the world. Rev. Miller had a firm commitment to the spiritual life of the parish; he wrote in a letter to the parish, "Adult education has been, is, and always will be the linchpin of a strong and vital Parish. We cannot begin to respond to the needs of our world or even of our own Parish until we are ready to try and understand why we should respond and what our resources are for making a response. Christ's word will not be proclaimed unless you proclaim it in word and deed. This requires some 'coming -to-grips' with life and with God in life. And that is what Adult Education is all about."

When Rev. Miller was called to St. John's in Bangor, ME he included this paragraph in a letter to the people of Holy Trinity, "Though we go to a new community and a new calling, we shall never forget you and the fine people of Holy Trinity Church. Our years here have been the happiest and richest of our lives. If God has seen fit to enrich the lives of others as well in these years, it has been our privilege and pleasure to be a part of this."

Shortly after Rev. Miller's death Holy Trinity Church received a \$10,000 gift of life insurance. Following the directive of our endowment policy the gift was transferred into the Holy Trinity Endowment "Legacy Fund". The gift will be held in perpetuity and, "Distributions from the fund shall be limited to: (i) capital improvements of the PARISH; (ii) outreach ministries and grants; (iii) seed money for new ministries and special one-time projects;".

We are grateful for the life and ministry of the Rev. John Miller. May he rest in peace and rise in glory.

FAMILY WORSHIP REPORT Family Worship is held every 2nd and 4th Sunday of the month. As in the past year, Cat Reith- Lowery continues her commitment in providing the lesson and activity each session. The model remains the same as in the past year where families start off in the sanctuary and are dismissed before the readings to join other families in the Parish Hall. The families participate together in the lesson and activity and are then welcomed back into the sanctuary to receive The Holy Eucharist.

Families are encouraged to offer ideas and suggestions to the program at anytime. Since we are a small, tight knit group, we can often implement changes in order to fit the ages and stages of our participants. Budget wise, our biggest event of the year continues to be Vacation Bible School, followed by the Christmas Pageant. We have worked as faithful stewards with our budget and are grateful for the emphasis placed on Family Worship.

It is our hope in the upcoming year that we have a consistent number of families participate and new families join.

VACATION BIBLE SCHOOL REPORT

VBS was held for the seventh consecutive year at Holy Trinity. This year we had additional campers and staff from Bethlehem Lutheran Church. The total number of registered campers was 47, along with 25 staff members. The theme this year as called "Maker Fun Factory". We returned to our full week format, Monday- Friday to have consistency.

VBS planning begins in March or April with an email to the core staff group asking if they would like to be involved again. We decided on the weeklong format and the date through the email thread. A staff meeting was held on June 27, 2017 to further hash out details. We have found that this planning method works effectively, as we have a team that is comfortable with the planning and implementing of VBS.

The team attended SAFE Church training as well. It is our goal to have ALL adult volunteers be trained by next year. We even had non-parish members, who are volunteers, attend, or have agreed to attend training in 2018. Volunteers also have a CORI on file. These practices show that HTEC is committed to child-volunteer safety.

The weeklong VBS program was a faith filled, entertaining and educational event. The parish continues to support this ministry by donating time, talent and treasure. Donations were more monetary this year with regards to lunch and snack, as the menu was slightly complicated, and shopping was easier done by our lunch/ snack leader. Sets and supplies were borrowed or given to us this year. Bethlehem Lutheran and New Hope Churches were planning on hosting a VBS, but plans led them to cancel so they shared their bounty with HTEC. This enabled us to take on twice as many campers as we had budgeted for.

Building use was similar to 2016, as the YMCA still occupied the lower level of the building. We used the Parish Hall, sanctuary, Undercroft and backyard space. Leaders were able to walk campers outside to access the lower level.

A meeting was held between Susan Howland and Eileen DeMings to process this year. The meeting was extremely beneficial and plans for VBS 2018 are currently in the works.

- Training for adolescents on reproductive health.
- Providing mosquito nets.

WARDENS' REPORTS

SENIOR WARDEN'S REPORT

It has been another busy year at Holy Trinity. The following is the year in review organized by worship, Christian education, and mission and outreach:

Worship events started with an Epiphany Supper on January 6, 2017. Our annual meeting took place during the service on January 29, 2017. Mardi Gras Pancake Supper February 28, 2017. During Lent there was a Seder Supper on Maundy Thursday followed by a prayer vigil, and an evening Good Friday service leading to a joyous Easter Sunday Service. Pentecost and Trinity Sundays were celebrated with special music from the choir. Blessing of the Animals on October 8, 2017. All Saints Day, November 5, 2017, included the baptism of David DeMings. On December 10, 2017 we celebrated Fr. Richard's 40th Anniversary to Ordination. Fr. Richard and members of the Holy Trinity choir took part in an ecumenical Thanksgiving service held at Bethlehem Lutheran Church the Tuesday before Thanksgiving Day.

Christian Education - In March vestry members attended Leadership Day at the diocese and April 8, 2017 the vestry gathered for a retreat at the North Brookfield senior center. The Seder Supper on Maundy Thursday was an instructional eucharist. Family worship did the Stations of the Cross Good Friday Story Walk. Family worship presented another Vacation Bible School, August 14-18, 2017. The stewardship breakfast and pledge card in-gathering were held on November 19, 2017. Advent wreath making was offered on December 3rd and 4th. Pam Mott, Canon to the Ordinary, joined us on December 10th to facilitate a Mutual Ministry review. Family worship pageant, "Heaven and Nature Sing," took place on December 17, 2017. In addition, the combined bible study continued with Bethlehem Lutheran Church on the first and third Wednesdays.

Mission and outreach - the annual Souper Bowl of Caring took place on February 5, 2017. The Community Garden project with Bethlehem Lutheran continued again this year on June 3rd and 4th. The community has seemed to take ownership after two years of help from the two churches and a grant. The annual church picnic was on July 2, 2017 and was well attended by the community. The ECW held the annual cookie sale on December 17, 2017 and the proceeds were given to St Luke's Guest House and the Heifer Project.

There were two other events that need to be mentioned. Joe DiSalvatore invited the parish to a seven course Italian dinner in honor of his birthday on June 28, 2017. In November we had said good by to the Kurt and Dorothy Frisch as they retired and moved closer to family.

Some administrative accomplishments made this year. Susan Howland introduced electronic giving. Hooks were installed in the pews to serve two purposes: they hold laminated giving cards so anyone that gives electronically can have their offering blessed by placing them in the offering plate. The hooks also hold new welcome cards designed with the help of Tamsin Lucey, Peg Nelson and Lynn Garland. A pastoral care team was formed to help follow up with membership and to identify needs in the parish. Our Sexton Hector Chapa resigned in February after 3 years of service. Brian Canty was hired and will still be available for special projects but his health made it difficult for him to continue. Greg Nikolla was hired in November. God continues to send us the right candidate for sexton each time there is a need.

The building committee was busy this year with many small projects and a large kitchen renovation. Holy Trinity received a grant from the diocese to make kitchen renovations to bring the kitchen up to health department codes. September saw the YMCA rental come to conclusion. The building committee continues to look for opportunities to rent our space as our building is an outpost in our community.

It has been a privilege to serve as your Sr. Warden for the last two years. I am thankful for a very supportive community, vestry and staff. I wish Godspeed to John Grant when he is elected the next Sr. Warden of Holy Trinity and ask your prayers for him.

ADMINISTRATIVE AND BUILDING

BUILDING AND GROUNDS REPORT

In 2016 a Building Committee formed to look at the current and long-term needs of our nearly 150-year-old building. Tamsin Lucey, Susan Howland, Jean Frost and Nate Lowery are the current members. We met once in 2017, informally on several occasions, and by email. We reviewed what we have accomplished in 2017 and made some decisions about planning ahead for 2018 and beyond.

2017 Improvements

The undercroft kitchen renovation to bring us up to health code discussed in 2016 became a reality in 2017. More investigation into codes, visits by the building inspector, the health inspector and the plumbing inspector were needed before we could move ahead with a plan. Cat Reith-Lowery drew up architectural drawing for the final project which were approved by the various boards and the vestry approved a two-phase renovation pending available funds. We applied for a Ministry Development Grant from the diocese and we were granted \$6,625, which allowed us to combine the two phases into one for the best price. Tamsin and Susan were the "general contractors," coordinating all the sub-contractors necessary for the job. Tamsin did most of the on-site day-to day oversight during the work, and many other people took on pieces of the project, like moving large equipment in and out: thank you Dave DeMings! Here is what was done:

- Carpenter removed counter tops and modified the cabinets as necessary to install new sinks and he cut down and moved the peninsula away from the stove.
- Sink removed in the butcher block island and replaced with more butcher block.
- Purchase and installation of a 3-bay sink.
- Purchase and installation of a handwashing sink.
- Purchase and installation of a prep sink.
- Purchase and installation of a commercial dishwasher.
- All new faucets.
- Plumbing modifications to facilitate renovation including installation of a grease interceptor in the boiler room.
- Electrical modifications for the renovation.
- Installed granite countertops.

Cost: \$21,911 offset by the grant of \$6,625. Food service permit issued.

Tangible Property added in 2017:

- New Office Printer
- New HP Desktop Computer and associated software.
- Two new floor fans
- 27 new prayer books
- Station of the Cross #12

Repair and Maintenance:

In addition to the capital improvements, regular repair and maintenance was done: \$4,927. This budget line was over budget by almost \$1,000 and included:

- Boiler tune-up and inspection certificates: \$770
- Building inspection certificates: \$200
- Fire Alarm monitoring, inspection and service calls: \$925
- Fire extinguisher and exit light inspection: \$397
- Snow blower tune-up: \$90.
- Snow shoveling: \$2,000 (Some of this cost was charged as a direct YMCA expense.)
- The United Way offers a "Day of Caring" where volunteers come to non-profit organizations and do one-day projects. Tamsin coordinated this opportunity for us and the "Day of Caring" crew cleaned-up brush from around the building.

2018 Anticipated Capital Improvement and major repairs:

- Replace 3 windows that contain lead in the undercroft kitchen area.
- Fix the two heaters in the undercroft kitchen; one is necessary to keep the pipes from freezing under a sink.
- Re-point and repair the brick at the back of the church.
- Paint the outside yellow trim and repair wood rot as needed.
- Quote for replacing windows in the parish hall.
- Evaluation of the slate roof for slipping slates.
- Now that the YMCA has left, we have the opportunity to look at a long-term rental of the classroom wing. We had an inquiry from a couple who run a Montessori School looking to open an additional program in Southbridge; they are interested in the classroom space. The vestry gave support to move forward. If we can work out a mutually agreeable arrangement and have a firm rental commitment we will move forward with the renovations in the classroom wing, specifically the restrooms. This will be a large undertaking and we have asked Cole Contracting to bid the job.

We are ever grateful for all the "Building Angels" (you know who you are!) who take care of small repairs if they see a need. Additionally, Tamsin gives generously of her time and talent and deals with many day-to-day issues, and keeps the clutter and entropy in check; Jean is always willing to think through issues and do what is needed; Nate is the thermostat guardian extraordinaire and consultant architect, and Cat researches all our odd requests for architectural information.

Much gratitude goes to all the "Grounds Angels" who mow, trim, plant, rake and do many other jobs. They are wonderful stewards of our property

Finally, we are thankful for Howie Swett, our neighbor, who has accepted the contract to keep the snow removed from our property for the last 3 years; he is exceptionally reliable and diligent. We have had three sextons this year; Hector Chapa left us in February after 3 years, Brian Canty was with us for 7 ½ months, and Greg Nikolla joined us on November 15th. We thank all of them for keeping the building clean, neat, and safe and for all the extra projects they do for us.

FINANCE COMMITTEE REPORT

The mission and purpose of the Finance Committee is to serve as stewards of the financial resources of the parish. While the vestry has ultimate responsibility for all the resources of the parish, the Finance Committee can share this responsibility, and that of the treasurer, by bringing its knowledge and experience to bear on parish financial matters.

The Finance Committee is a committee of advice to the vestry. The Vestry approves its members. The responsibilities of the Finance Committee is to provide the treasurer with a group of thoughtful, committed members of the parish with whom the treasurer can discuss ideas and parish financial matters, and assist in the development of the annual parish budget.

The Finance Committee met once in September 2017, and by email in between. The September meeting was spent working on a draft budget which was presented to the vestry in October. After the pledges came in showing a \$22,000 deficit, several budget revisions were drafted. Ultimately, with some December pledges we were able to draft a lean, but balanced budget.

We would like to thank the members of the 2017 Audit Committee: Lynn Garland, chair, Jerry Helbig and Josh Spooner, for their diligent and timely work to complete the audit. We also are grateful for the work of our long-time pledge secretary, Mick Kalber, and our bookkeeper, Chris Bolte, who help the parish with financial accounting and accountability.

As always, we pray for the needs and ongoing work of the church.

TREASURER'S REPORT

Operating Budget

Income: overall income exceeded budget by \$14,542. Budget: \$125,301; Actual: \$139,843, after adjusting for prepaid 2018 pledges. Why?

- Fundraisers: \$189 over budget
- Rental income over budget by \$1,550
- Plate offering over budget by \$3,767
- Prayer Book dedication gifts of \$430
- Pledges were \$1,295 over budget with no arrearage, which was budgeted at \$4,400
- Checking interest \$199 over budget
- Other miscellaneous unbudgeted income
- Trust income was up by \$701. ¹/₂ of that was because we started taking distributions from the Legacy Fund, which has restricted use: "Distributions from the fund therefore shall be limited to: (i) capital improvements of the PARISH; (ii) outreach ministries and grants; (iii) seed money for new ministries and special one-time projects;".

Expenses: overall expenses were over budget by \$4,626. Budget: \$125,301; Actual: \$129,927 Why?

- The capital improvement line is intentionally over budget as we moved ahead with the unbudgeted Kitchen renovation for a cost of \$21,911, which was offset by a Ministry Development Grant of \$6,625 from the diocese.
- Oil was close to budget, but money is put into the fuel fund reserve monthly because we have a large oil tank and we can take advantage of buying oil in bulk at a lower price.
- After vestry consideration, all lines over budget were paid for with reserve funds and income over budget.
- Many lines were under budget, some because funds were not needed and others because of frugal spending, which offset the overbudget lines.

Non-operating Budget

The non-operating budget contains un-budgeted funds received and designated or restricted for a particular mission or purpose.

- We received \$2,640 in donations to the **Holy Trinity Building Fund** in honor of Joe DiSalvatore's 60th birthday.
- A gift of \$50 was given to the Holy Trinity Organ Fund, a fund for maintenance and repairs.
- The net Income from the YMCA rental of \$16,950 (In addition to prior years rent in reserve) is now in the new **Holy Trinity Savings Fund.** 10% of the net income was put into a Mission Fund. **See * below**.

Memorials

- We received memorial donations in 2017 of \$765; most of this was given in celebration of Fr. Richard's 40th anniversary of ordination; \$500 was spent to purchase one station of the cross.
- We received a \$10, 037.86 memorial gift of life insurance from The Rev. John Miller, former rector of Holy Trinity Church. This windfall gift was put in the **Legacy Trust fund** held at the diocese per the endowment policy.

Outreach: Total \$13,957.36

- Childreach/PLAN \$395 was donated and sent to Childreach to sponsor Nicholas in Kenya.
- The 2017 United Thank Offering was \$710.83.
- The Good Friday offering was \$76 and sent to support The Episcopal Church in Jerusalem and the Middle East
- Food Share The 2nd Sunday loose plate for Food Share was \$506.63 with an additional \$200.50 from the "Souper Bowl" soup sale.
- The mission plate offerings were \$2,340.06 and were given to various missions (separate report).
- Parrettie Fund alms given to various people in need: \$7,844.30.
- The Rector's discretionary fund inflow for 2017 was \$2,400 funded from the Parrettie Fund, with \$1,884.04 given in alms to various people in need.

***The** finance committee recommended, and vestry approved putting the YMCA Rental income into a "savings account" to be used for needs outside of the operating budget. 10% was tithed to Mission; there is \$4,095 in the Mission Fund.

- Electronic giving was discussed and approved by the vestry in 2016 and implemented in February 2017.
- Please see the Statement of Financial Position for the total financial picture.
