Minutes from the 2018 Annual Meeting of Holy Trinity Church

Following the Collect, at 9:35 AM the meeting was called to order by Father Richard Signore. Reports and minutes of the 2016 Annual Meeting were provided to parishioners prior to the meeting and some were available in the back of the church. A motion was made and seconded to accept the minutes from the 2016 Annual Meeting. At 9:40 am Nancy Waugh read the slate of nominees for Vestry positions and announced that other nominations would be accepted from the floor. John Grant nominated himself for the position of Vestry delegate to the Diocesan Convention. Susan Grant nominated herself as non-Vestry delegate to the Diocesan Convention. Lorraine Brumskine nominated herself as the alternate Vestry delegate to the Diocesan Convention. Then the service resumed with the reading of Psalm 62 verses 6-14.

The treasurer was called forward to give the report and present the 2018 Budget. Susan Howland offered gratitude to all who pledge and give to the church and to all those who worked with her to manage the finances of the church. Susan also highlighted all the ways money goes out in mission which is unbudgeted. There were no questions about the report or Budget. The service continued with the Old Testament lesson and homily on Psalm 62:6 – For God alone my soul in silence waits.

Nancy Waugh made a motion to close the nominations from the floor that was seconded and carried. A motion was made, seconded and carried to have the secretary cast unanimous vote for the slate as presented. Nancy then gave her report which included a thank you to the Vestry and officers, the Building Committee and the Family Worship Team and the whole staff. She commented on the glass front doors through which we welcome strangers. Father Richard asked if there was any old business or new business to be brought before the gathered. There was none. He asked for comments on the changes that had been made to the liturgy and there were none. Father Richard thanked all for their participation. A motion was made, seconded and carried to close the Annual Meeting

- Pledges
 - Pledged amounts collected confidentially in each annual stewardship drive may only be known to the Stewardship Chair, Pledge Secretary, Treasurer and if they choose to know, the Clergy.

- Have Cole Contracting provide the length of gutter guard missing and install the gutter guard.

VACATION BIBLE SCHOOL REPORT



VBS was held at Holy Trinity Episcopal Church from August 6-10, 2018, in the morning. This was our 8th consecutive year! The theme was "Shipwrecked" and we continue to use the curriculum from Group Publishing, as our core group is familiar and comfortable with it. We had 29 registered children and 10 adult volunteers.

Classes were set up throughout the church. Bible stories were held downstairs, as well as Imagination Station. Games were held in the backyard. Snack and Lunch were served in the

undercroft. Our opening and closing classes remained in the parish hall.

Funding for Vacation Bible School continues to be a high priority. Sponsorships from the congregation as well as food donations made a large impact on our budget. Each VBS child was given a T-shirt as well as five take home science "gizmos" as part of the program.

Planning for VBS started in the spring. We had one meeting with the core staff. Ordering of materials was done in June. We ordered extra supplies and returned them for a refund after VBS ended. This was helpful!

VBS is a strong ministry that continues to provide a safe and loving environment for our children during the summer. We did like the one-week format and will continue to tweak the program to fit the needs of our growing children.

Nyangoma area of Kenya, Africa, along the shore of Lake Victoria. The family lives in a house made of mud and sticks with a corrugated metal roof. They get water from a rain catchment in the yard, and they share a latrine with neighbors. They are Christian and speak Luo. Nicholas walks 45 minutes to primary school. His favorite subject is Math.

I find it wonderful to think of all of us doing acts of kindness, volunteering, worshipping together, and making donations to charities through the Mission Plate as acts of "doing" for Jesus. Our donations to the seven charities we gave to this past year were given to so many families around the world and in our own communities. FOOD PANTRY AT BLESSED JOHN PAUL II PARISH MINISTRY REPORT

As I reviewed my documents to write this report, I found that back in January 2018 I asked for all of you to help revive the food pantry ministry, which had fallen by the wayside after Pat Bair passed. In the beginning, it appears that I made the following requests: First, that the children be involved in the process by having them carry food items up to the altar during the offertory. While not an every-Sunday occurrence, this has happened a few times, and certainly my heart has been warmed when I see the joy and pride on the children's faces as they carry items up for the offertory blessing. I think we should make more of an effort to make sure there are products to be offered and encourage the children's participation.

Another suggestion was for the children to create Bible verse messages of hope and love onto construction paper that could be attached to the items before they are brought up to be blessed. Then the people who use the food pantry will receive more than just food for their bodies; they will receive nourishment for their souls as well. We did create stickers that were placed on packages, though this never really became a significant part of the process. I think it still might be worth revisiting to see if we can encourage the idea to grow.

When I first took on this project, I thought that it might be useful and more personal to issue a challenge of sorts, asking for us all to donate a non-perishable food item that we each would like to find at the food pantry if we were in need of a comforting meal and had no money to buy ingredients. To that end, I thought it would be wonderful if we each brought in one of our favorite foods, a comfort food, a favorite ingredient, or something more unusual that one does not typically find in a food pantry - something that would nourish one's stomach as well as one's soul.

A while later, it was suggested that we find out what sorts of items people who visit the pantry are actually looking for, so I made a call to the people who run our local food pantry housed down the street at St Mary's church, part of Saint John Paul II Parish. From them, I learned what some folks already knew, which was that the food pantry can get practically free food from the Worcester County Food Bank (WCFB) when it comes to many of the staples we might think of such as rice, pasta, canned meats, etc. What they do not get practically free are the kind of things that make those staples into a meal. For example, I just looked up the WCFB on line and found that they prefer not to get donations of items in glass jars, which would mean that foods like tomato sauce and pickles are not among the foods that St. J.P. II would get from WCFB. The following chart shows some of the items that they could use because they do not get them from the Food Bank.

Toilet tissue, soap and dish soap are on here twice because those are things that people need that none of the typical support systems provide. I will admit that I actually considered putting them on the chart for each month, as they are a necessary item that even WIC and other federal and state based food assistance programs do not cover.

The above list/chart is revised from the original notifications from the middle of 2018 because I did some revising as I was creating this for the Annual Report.

Finally, to end this report I just want to thank everyone who has so generously helped support our local food pantry, encourage everyone to continue these good works, and finally, I especially want to acknowledge and thank Bill Nelson for bringing the donations over to St. John Paul II in a timely fashion.

One of the largest grants (\$66,668.13) was awarded to the Massachusetts Companion Diocese with Tanga, Tanzania to provide for the creation of a kitchen and dining areas for the Hegongo Holy Cross Secondary School.

ADMINISTRATIVE AND BUILDING

BUILDING AND GROUNDS REPORT

The Building Committee, Tamsin Lucey, Susan Howland, Jean Frost and Nate Lowery look at the current and long-term needs of our nearly 150-year-old building and arrange for work to be done. The building committee met on Sunday, June 3rd at other times informally, and by email and text when necessary.

We started the year by getting a number of quotes from Cole Contracting Co. to move forward with the anticipated projects identified in 2017. The major initiative was to upgrade the classroom wing with the hope and prospect of renting the space, while also addressing the exterior maintenance. What we learned was it will be at least a \$50,000 investment to bring the classroom space up to code and then our rental prospect fell through. We did move forward on the exterior and interior repairs and addressed all the 2018 anticipated capital improvement and major repairs.

The committee also reviewed building use agreements for parish members and non-parish members and suggested that all people using the building for personal endeavors have a building use agreement in place. This is prudent for insurance and best practice.

2018 Capital Improvement and Major Repairs: Cost: \$26,560. When the budget was expended we used Building and Savings Fund money to pay for the expenses.

- Completed the replacement of the 3 windows that contain lead in the undercroft kitchen area.
- Replaced the exterior door in the undercroft kitchen "annex", which was not functioning, was out of code and also had lead paint.
- Replaced the entire 60-year-old baseboard heating in the classroom wing; some was leaking and we looked at this as a long term investment in oil conservation.
- The brick on the sides and rear of the church was repointed.
- A large hole in the slate roof (from storm damage) was repaired; the roof company inspected the rest of the slate roof and replaced a number of missing and slipping slates.
- While we had the lift for the roof we had the rotten trim at the rear of the church repaired and painted.
- Also, while we had the lift, we hired Hector Chapa to trim the tree limbs that were overhanging the church roof (Hector was assisted by Brian Canty and friend.)
- Two pads were leveled and pea stone put down for the front bench and trash cans. Thanks to Dave & Teddy DeMings, Lana, Bill, Will, Joe & Sam Pieczynski, Dan Macumber and Brian Canty.

Tangible Property added in 2018:

- Backpack vacuum cleaner
- Programmable thermostats: one in the foyer and one in the Parish Hall.
- Internet router
- We lease our photocopier with a service contract and printing allowance. We signed a 5-year lease on November 1, 2018.

Repair and Maintenance: \$8,640

In addition to the capital improvements, regular repair and maintenance was done: this budget line was 100% over budget mostly because the budgeted amount was not adequate and because we had reserve funds to pay the expense. Brian Canty, our former Sexton, volunteered his time to work on repair projects so we committed money for supplies. Costs included:

- Boiler tune-up, boiler repairs, including thermostat, and inspection certificates: \$2,500
- Plumbing and electrical repairs: \$1,388
- Building inspection certificates: \$200

- The Town of Southbridge Health Department inspected the kitchen. Food service permit issued. No fee with petition for fee waiver.
- Fire Alarm monitoring, inspection and service calls: \$1,345 (High because smoke beam detector was faulty.)
- Fire extinguisher and exit light inspection: \$164
- Snow blower and mower repair: \$90.
- Sewer/drain line cleaning: \$200
- Snow removal: \$1,175
- During our annual building inspection we learned that the Sacristy door, because it is a posted fire exit, must be unlocked at all time. This required some relocation of items, installing locks on cabinets and a few other minor alterations. (Thanks go to Brian and Tamsin for executing this requirement.)
- Repaired fire exit door in parish hall (Required for Building inspection.) \$945
- Front bench refinished (Brian Canty)
- Undercroft kitchen painted (Brian Canty)
- Family Worship classroom painted (Brian Canty and Roy Baum)
- Poles for the Christmas greens painted (Paul Aloia)
- Supplies for repair and maintenance: \$572

We will identify Capital Repairs and Improvements for 2019. Some already identified:

- Repair/Rebuild the front entrance foyer steps (2 estimates \$3,500-\$4,600)
- Re-shingle the street side of the parish hall ~\$6000
- Replace the Parish Hall windows (One bid \$18,642)
- Repair, scrape and paint the trim on the church (One bid for \$29,363.00, with tower add \$20,924.00)
- There are a few windows that are broken
- Stained glass windows need to be evaluated

We thank our sexton, Greg Nikolla, for keeping the building clean, neat, and safe, and for accepting the contract for the snow removal.

We are ever grateful for all the "Building Angels" (you know who you are!) who take care of small repairs if they see a need. Additionally, a shout-out to Brian Canty and Tamsin who give generously of their time and talent dealing with many day-to-day issues, and keeping the clutter and entropy in check; Jean is always willing to think through issues and do what is needed, especially dealing with bats and thermostats; Nate jumps in when needed especially for architectural advice.

Finally, we thank all the "Grounds Angels" who work in quiet ways taking care of mowing, trimming, planting, raking and many other jobs. They are wonderful stewards of our property

FINANCE COMMITTEE REPORT

The mission and purpose of the Finance Committee is to serve as stewards of the financial resources of the parish. While the Vestry has ultimate responsibility for all the resources of the parish, the Finance Committee can share this responsibility, and that of the treasurer, by bringing its knowledge and experience to bear on parish financial matters.

The Finance Committee is a Committee of advice to the Vestry. The Vestry approves its members. The responsibilities of the Finance Committee are to provide the Treasurer with a group of thoughtful, committed members of the parish with whom the treasurer can discuss ideas and parish financial matters, and assist in the development of the annual parish budget.

The Finance Committee met once in September 2018, and by email in between. The September meeting was spent working on a draft budget which was presented to the vestry in October. By the time the final pledges came in December we were able, with some minor revisions to present the vestry with a balanced budget. The finance committee has been working on rental agreements and thinking forward, along with the building committee, about possible uses of our unused space.

We would like to thank the members of the 2018 Audit Committee, Lynn Garland, chair, John Grant and Josh Spooner for their diligent and timely work to complete the audit. We also are grateful for the work of our long-time pledge secretary, Mick Kalber, and our bookkeeper, Chris Bolte, who help the parish with financial accounting and accountability.

As always, we pray for the needs and ongoing work of the church.

TREASURER'S REPORT

Operating Budget

Income: overall income exceeded budget by \$3,953. Budget: \$112,235; Actual: \$116,188.

A few reasons why:

- Fundraisers: \$222 over budget
- Rental income over budget by \$185
- Plate offering over budget by \$2,826
- Checking interest \$234 over budget
- Trust income was \$240 over budget
- Other miscellaneous unbudgeted income

Expenses: Expenses will be discussed in two categories: Operating expenses and Capital Improvement Expense:

- Operating expenses were \$116,030 which is about \$4,000 over budget. This is primarily due to the church repair and maintenance budget and the funds needed were drawn from savings.
- The capital improvement expense was \$26, 560, which is \$22,950 over budget. The building committee, with vestry approval recommended a number of necessary building projects and the needed funds were taken from savings. (See Building and Grounds report for details.)
- Oil was over budget so we could fill the tank at a good price.
- After vestry consideration, all lines over budget were paid for with reserve funds and income over budget.
- Many lines were under budget, some because funds were not needed and others because of frugal spending, which offset the overbudget lines.

Non-operating Budget: The non-operating budget contains un-budgeted funds received and designated or restricted for a particular mission or purpose.

- We received \$3,300 in donations to the Holy Trinity Building Fund in honor of Tamsin Lucey and Susan Grant's 60th birthday.
- A gift of \$150 was given to the Fitzpatrick Fund by Carol Hanson.
- We submitted an insurance claim for roof damage and received \$1,979, which was transferred to the Building Fund to offset the roof repair.
- The Parrettie Fund income was \$7,915.15.

Outreach: Total \$13.957.36

- Childreach/PLAN \$396 was donated and sent to Childreach to sponsor Nicholas in Kenya.
- The 2018 United Thank Offering was \$1,015.42.
- Food Share: The 2nd Sunday loose plate for Food Share was \$303 with an additional \$217 from the "Souper Bowl" soup sale.
- The mission plate offerings were \$1,345.17 and were given to various missions (separate report).
- Parrettie Fund alms given to various people in need: \$4,855.79
- The Rector's discretionary fund inflow for 2018 was \$2,400 funded from the Parrettie Fund, with \$2,438.60 given in alms to various people in need.
