



#### Dear Friends,

Whatever ministry goals we may have considered for 2020 at this time last year, the Covid-19 explosion shattered any expectations we may have harbored. In fact, we were taken immediately to consider how organizations survive under absolute duress. We continued our primary identifiers, and on reflection, grew tremendously.

First, we never lost sight of the fact we are a worshiping community. So we wait, patiently, with the cry of God's people, "Next year in Jerusalem;" right on Hamilton St.!!

We have some people at the church building to sing, to encourage you to participate in the service in your home.

I look forward to the time we can all worship together, even if we can't sing together yet. When the time is right, we

We started 2020 by reading "Things Seen and Unseen," by Nora Gallagher. We read the first two chapters, Advent and Christmas, and met at Diane Nichol's house in January. We met again at Susan Howland's house on March 8th to talk about the Epiphany and Lent chapters. Both times we had a lively discussion.

Several women "mentored" children who helped at the Mardi Gras Pancake Supper.... many thanks!

For Lent we offered the opportunity to read <u>The Poetry of Lent: A Lenten Companion to Mary Oliver's "Devotions".</u>

The ECW bought a group license for the companion and all information was posted to our Facebook Group.

With Diane's Cancer diagnosis combined with COVID19 we did not hold any more in person meetings, but there was a fair amount of connection on our Facebook Group, and we were not neglectful of pastoral care. Many women wrote cards, made phone calls, and checked up on parish members and continue to do so.

Diane, Traci, and Hope all had major surgery in August. Along with prayer vigils for all three, \$363 was contributed for flowers and food. Traci, Hope, and Diane had flowers delivered either in the hospital or at home, and Traci and Diane received meals delivered to their houses from the ECW and from others. The total spent was \$282, so we have \$81 in reserve for future pastoral care needs.

In August we started collecting recipes for a new Holy Trinity Cookbook. It will be available in 2021.

We were sad to say good-bye to Diane on October 16<sup>th</sup>. Her memorial service was held by Zoom from Holy Trinity on October 24<sup>th</sup>. In Memory of Diane, we offer this poem:

#### DAUGHTERS OF THE KING REPORT

I find it difficult to write this report this year because so much has changed in how we meet and function. If you asked me a year ago what zoom is, I would have responded "something you do to focus a camera." Today, zoom has become our lifeline for communication. However, what has not changed is our focus on our vows of prayer, service and mission.

We had to redefine "how" we do mission under the current conditions of the pandemic. Due to the pandemic, we have been unable to go to the Southbridge Rehabilitation Center, as we did last year, to do arts and crafts with the residents. However, they continue to be in our thoughts and prayers. Also, we have been unable to collect and deliver our supplies (laundry and dish detergent, etc.) to St. Luke's Guest House since our church building and masses have been restricted and closed. Despite this, many of us in the parish continue to give our spiritual and financial support to St. Luke's.

This year through prayer and discernment, we have initiated a new "companion relationship" with the Sons and Daughters of the King in Liberia. The Episcopal Church in the USA has had a decades-long companion relationship with the Episcopal Church in Liberia was once a developed nation. The ravages of civil war and political unrest have destroyed the country's infrastructure. The roads are in poor condition; there is little electricity and limited running water. This has led to widespread poverty. The local churches run the schools which have become a "safe haven" for the children.

Our goals are to establish a ministry of prayer and aid through the Sons and Daughters in Buchanan, Grand Bassa County in Liberia. Our mission of aid is to provide critically needed clothing, school supplies and toiletries for the children. We sincerely need the prayers and help of our fellow parishioners in collecting boy's and girl's clothing, school supplies, and toiletries. The need is REAL. Donations are being received at the ramp door to the foyer on Tuesdays and Thursdays when Chris is in the office. We are also accepting monetary donations to help with the shipping costs of these items to Liberia. Church accounts have been set up for the Liberian Project. We ask your support through prayers and donations if you are able to do so.

The Daughters of the King are also members of the Mission and Outreach Committee. We continue our focus on ministry by identifying eligible charities to be recipients of our mission plate donations. We identify charities on local, national, and international levels which we feel reflect the overall mission of our church. We thank everyone who has donated to our mission plate over the past year. Every donation matters, as it empowers us as a parish to better the lives of those in need.

Every Daughter of the King takes a lifetime vow to live by the "Rule of Life". The "Rule of Life" encompasses the "Rule of Prayer", the Rule of Service" and Evangelism. In a Daughter's life, nothing can be substituted for prayer. It is a daily source of life and strength. Through our rule of daily prayer, we strive to grow a deepening relationship with God. We, the Daughters, maintain a prayer list, which we pray daily, petitioning for the healing, guidance, and special concerns of our parish, country and world, in addition to praying for the departed and mourning of our parish. Needless to say, we have been busy in prayer this year!!

The year 2020 has been a year of devastating sickness, death, loss, unemployment, political unrest and division in our country and the world. It has also been a vital year of prayer, hope and courage as we are learning how to reach out and care for each other. More than ever, we as Christians need to exercise the power of prayer. God calls us where we are in love to do His work, through prayer, discernment, service and mission.

Family Worship is the primary Christian Formation program at HTC for children. On average, there are 5-6 children in attendance. We continued to work with the "Lesson Plans that Work" curriculum from the Episcopal Church website. This is the same curriculum we used when Family Worship was created.

There have been a few activities that the Family Worship group has participated in even during the struggles of covid-19. We dropped off 'Worship from home bags' that included the BCP, The Hymnal 1982, and the Adventure Bible. This would allow families to continue to join on Sunday mornings and the kids to use the books to follow along. We have taken advantage of zoom. We got 'together' for Good Friday/Easter via zoom and created Cross pictures along with window paintings of crosses in a mosaic style. We have talked through service via Facebook comments, zoom coffee hours, and messages between families. The summer was taken off mostly due to Covid-19 and families finding their footings with the changing world around them. We continued to see families participate on Sunday Mornings during Facebook live services through the fall. As everyone finally got into the groove as winter started, we were able to get together after Christmas for Epiphany before the service and create 'glowing' stars to put into our windows to help guide everyone to Jesus' birth.

The Family Worship Ministry is always adapting to the ever-changing needs, ages, and stages of our children - many of whom are considered "pre-teen"! We are currently working through what 2021 will bring us as we continue to learn how to guide our children and get back to meeting via zoom and following the curriculum we have chosen.

#### WINTER COAT CLOSET REPORT

After meeting with the committee in October it was decided, if approved, we would open for an abbreviated season. Covid-19 Guidelines from the church, local Board of Health and other health sources in touch with DPH were received and followed. We solicited coat donations from the area churches, but found many churches were unable to assist due to not having in person services.

We opened November 7 and closed December 12. Masks were required and the number of people allowed to look through the racks was limited. Surfaces were sanitized after each visit and donations were kept aside for one week to assure safety. We kept a log of clients for contact tracing and kept air circulating with a fan and open window. We were able to serve close to 90 people and gave out 226 coats in six weeks. The volunteers were: Bill Nelson, Lynn Garland, Tricia O'Brien, Miriam Sanitago, Pedro Sanitago and myself. Sally Baum assisted with thank you's. We are grateful to the church members and staff who are always so supportive.

#### WARDENS' REPORTS

#### **SENIOR WARDEN'S REPORT**

It is wonderful to have the opportunity to reflect on the ways our faith community has followed God's leading during this extremely challenging year. The pandemic outbreak has changed our lives in so many ways, including the way we worship. And yet it has provided an opportunity to be reminded that God is with us always, in every circumstance.

The first unexpected challenge was no longer being able to gather in person for worship. While we did miss a couple of Sundays, members of our community quickly and generously shared their technical skill and time to make it possible to continue our shared worship on-line through Facebook live streaming.

Fr Richard, our organist and the liturgical team have done an amazing job of creating sacred space in the on-line format. We have learned to use Zoom for meetings and social gatherings. Fr Richard has used Zoom to provide Compline on-line on Tuesday evenings at 8pm and "Coffee Hour" after church Sunday morning and Thursday evenings at 8pm. He also conducted an Agape meal on Epiphany, January 6th. Creative solutions have been found for our Family Worship Team and our Stewardship Drive and In-Gathering. More information will be shared in those reports.

It has been important to us to maintain contact with everyone, especially those who are not able to participate online. Those folks have stayed connected through phone calls and mailing of the Tidings and the Weekly New Bulletins. Our communications liaison has worked closely with our church secretary to find new ways of sharing information quickly. More information will be shared in a separate Communications report.

In addition to the pandemic, we have felt the impact of the social unrest and calls for Racial Justice this year. Holy Trinity answered the call to become more informed about white privilege and systemic racism. We have provided a "Social Studies" group that meets once a month via Zoom. Currently we are beginning to study the "White Privilege" Curriculum provided by the United Church of Christ.

Holy Trinity did continue one in-person ministry this year. The ecumenical Coat Closet provided free coats again for six Saturdays in November and December. Safe practices were followed as recommend by the CDC. We were able to give out 226 warm winter coats in addition to scarves, hats mittens and snow pants.

Another unexpected challenge this year was the death of our beloved parish member, Diane Nichols, who had just started her first term as senior warden. Her loss has been deeply felt. As I had just started my first term as junior warden at the time, it was a big change for me to move into the role of senior warden. It has been a steep learning curve. Fortunately, we have an active and supportive parish and vestry. I am grateful for the support and patience that have been accorded me during this transition.

I am also grateful for the many examples of faithful service I have witnessed in our community. God's presence and the love of Jesus continue to sustain us. May we all remain open to receive and share these blessings as we continue our journey together.

#### **ADMINISTRATIVE AND BUILDING**

#### **BUILDING AND GROUNDS REPORT**

Grounds and Building 2020 Annual Report.

2020 was a busy year for the Building and Ground Committee, there were building issues that needed to be addressed. The following report is a summary of the work undertaken throughout the year. It is not in chronological order nor is it in order of importance. Similar items are grouped together purely for ease of reading.

Tower: slate roof, replaced missing/damaged slates and repositioned slipped slates Flashing replaced in 3 locations – addressing 1 known leak that manifested in damaged ceiling tiles in the undercroft on two separate occasions. Replacing the flashing in the 2 additional locations were preventative measures.

Trim – all the trim, including the ridges, dials, and crown molding on the tower roof above the bell tower opening was scraped, primed, and painted.

Flat Roof: was leaking, the old insulation was badly compromised, and because the drains were poorly designed run off water caused damage to the brick work at the front of the building resulting in water causing damage to the frame of the first window in the narthex and possible damage to ceiling tiles in the storage room that houses the electrical panel & fire panel. The roof was replaced, in doing so it was pitched to drain towards the back thus doing away with the need for drains at the front – by the foyer door. (the drains that are left in place are cosmetic only!) The water drains to the back of the roof to a new gutter and down spout.

Repointing was done to a small area of brick work between the foyer entrance way and the first window in the Narthex.

All the wiring, box and hardware associated with the town fire alarm system was removed at the request of the town fire department.

The grounds were admirably maintained by the small but very able mowing team, throughout the year even though the grounds and building were not used much by the parish because of COVID 19. A used lawn mower was purchased. Repair to the blade of the old mower was not cost effective.

The rail to the handicap ramp was identified as needing to be replaced – it is in bad repair and not building code compliant. The Building Inspector requires a sketch with specifications submitted before work can proceed. The building committee is working on getting a sketch and specifications done.

Repairs to the sidewalk to the undercroft will be ongoing. The chunk of concrete that broke off when the handrail fell down several years ago is not easily repaired and will need annual patching to maintain its integrity. (pass the building inspection)

Snow removal was taken care of by Greg Nickola, a separate agreement from his duties as sexton.

The approximate outer edges of the oil tank have been established.

The building passed inspection in January 2020

The Board of Health passed the kitchen inspection in November. There are 2 food service inspections each year.

The Church was required to pay \$200 for the inspection this year – previously this fee has been waived by the town because the church provided opportunities for the public to eat for free at events like the Pancake Supper – these events did not take place in 2020 because of the COVID 19 – so no waiver could be applied for.

Both emergency light fixtures in the parish hall needed to be replaced. The light fixture in the Narthex bathroom needed to be replace. The units were purchased by the church and installed free of charge by the sexton's brother-in-law, a licensed electrician.

The sexton, Greg Nickola, was retained despite the drop in building use due to COVID 19. Holy Trinity received a grant to help cover employee wages if they were retained during the pandemic. Greg continued to provide excellent service, performing his duties as required. He also facilitated moving family worship and coat closet items as needed. The parish hall floor was washed and waxed. Areas of the building got a spring clean.

A new de-humidifier was purchased to replace an old one no longer working properly. De-humidifiers are used in the classrooms and undercroft storage area and storage room, continuously spring through the fall to maintain air quality and prevent mold growth.

The need for adequate storage for Family Worship resources was discussed at length. A plan was established to provide storage for all the Family Worship resources in the storage room in the undercroft – the room closest to the external entrance door. (This storage room is currently used by The Coat Closet). Some work was started in the fall: All the family worship resources kept in Fr Richard's office were removed, all Family Worship items previously stored on the stage and in the parish hall were sorted out. A plan is in place to sort out the Family Worship resources currently in a classroom and an undercroft storage closet. The items in the parish hall will be moved downstairs in preparation for moving all the Family Worship resources in to the new Family Worship storage room when it is ready. To allow for the Family worship resources to be stored in the undercroft storage room, closest to the external door, the coats stored in that room for The Coat Closet will be moved to the storage area behind the undercroft storage closets. Plans in place to modify the space that houses the electrical and fire system panels to make it more useable for The Coat Closet.

Major repairs to the steam boiler were undertaken – the steam valve, activator and auxiliary switch and the condensate pump. Both boilers were serviced in the fall ready for the heating season. The Sanctuary radiators were drained and metal shims put in place to facilitate condensate return and help minimize leaks and knocking in the system.

When the church moved to Charter for phone and internet service – it was necessary to install a new phone line for the fire system.


The Building Committee continued exploring the opportunity to rent some of the classroom space to a local non-profit – in December 2020 it became apparent that there were too many obstacles to over-come to make the space viable for the potential non-profit.

Minor plumbing issues were handled by Greg Nickola and Brian Canty. Major plumbing issue was taken care of by Gordon Plumbing.

Brian Canty Joined the Building Committee in the fall of 2020

#### WEBSITE AND COMMUNICATIONS REPORT

Holy Trinity's investment in on-line communication became essential with the suspension of in-person services. Our leadership team immediately investigated and launched a few ways to keep our community connected.

First, we purchased a Zoom account to start meeting virtually to plan our way forward.

Second, we gathered the equipment (Computer, webcam, microphone etc.) to broadcast our services from our Facebook page using Facebook Live, bringing virtual services to our church community. We used our "Zoom Room" as a place to gather for a virtual coffee hour after the service. The recording of the service is made available on our Facebook page, and on our website. To comply with copyright law, we purchased a streaming/podcast license add-on to our Onelicense printing license.

Fr. Richard started offering weekly Evening Prayer, Compline and fellowship evenings on Zoom. Zoom is now used for vestry and other group meetings and we hosted Diane Nichols' memorial service on Zoom.

In January we set up an E-newsletter account with MailChimp, and in March started sending out weekly and then twice a week communication to keep people up-to-date on the fast-moving changes. In addition to being direct mailed to 73 people, the bulletin and a printed copy of the E-news is mailed to people without internet/computer.

The website was changed to be more friendly for virtual services: bulletin, Prayer Book and other service material and resources.

On the technology front, John Grant installed an Ethernet cable for a more stable connection to the internet. We switched to Spectrum Cable as Verizon could not provide the internet speed we needed for a good Audio and Visual experience on Facebook Live and Zoom.

Cat Reith-Lowery has spent nearly every Sunday since March setting up for the Facebook Live recording and providing tech support. Susan Howland is her "back-up" and otherwise monitors the live production, posting in the live chat relevant portions of the service.

The diocese is offering a grant of up to \$2,000 for technology expense incurred to stream the service and conduct virtual meetings. Susan Howland will complete the application due in April.

Susan is in weekly communication with Chris Bolte to bring information to and from the vestry and "communications" has extended into some pastoral care as we check in on parishioners, especially if they do not have computers and internet.

#### **FINANCE COMMITTEE REPORT**

The HTC Finance Committee for 2020 consisted of Susan Howland, Josh Spooner, Peg Nelson, and John Grant (Treasurer).

The mission and purpose of the Finance Committee is to serve as stewards of the financial resources of the parish. While the Vestry has ultimate responsibility for all the resources of the parish, the Finance Committee can share this responsibility, and that of the treasurer, by bringing its knowledge and experience to bear on parish financial matters.

The Finance Committee is a Committee of advice to the Vestry. The Vestry approves its members.

The responsibilities of the Finance Committee are to provide the Treasurer with a group of thoughtful, committed members of the parish with whom the treasurer can discuss ideas and parish financial matters, and assist in the development of the annual parish budget.

The Finance Committee met twice in 2020, on November 5<sup>th</sup> and on December 7<sup>th</sup>. In addition to the committee, our Rector, Father Richard, and our Senior Warden, Lynn Garland, were invited to these meetings. Both of these meetings took place on ZOOM.

The focus of the November 5<sup>th</sup> meeting was the creation of a budget for the year 2021. In addition to the budget the agenda for the December meeting included additional topics, most importantly was the re-allocation of the Treasurer's task. Shifting some responsibilities to the Finance Committee Chair, recognizing the significant workload and responsibilities on the Treasurer.

The budget development continued during the December 7<sup>th</sup> meeting. The budget that resulted from this meeting was slightly in the red. As more pledges came in, a balanced budget became possible. Between the December Finance Committee Meeting and the January Vestry Meeting more modifications on the budget were put into place. The Finance Committee was kept apprised of these updates via email. A balanced budget was accepted by the Vestry at the January 13<sup>th</sup>, 2021 Vestry Meeting and is now ready for presentation at the Annual Meeting.

This balanced budget would not have been possible without the expertise and efforts of Susan Howland, who went above and beyond. I would have not survived this year without Susan's help and council.

#### **TREASURER'S REPORT**

The year 2020 has presented us with challenges, many of which were financial. The expectation was that there might be a shortfall in donations as we've been worshipping mostly remotely this year. I am pleased to report that our parishioners came through with pledges meeting our goals, within the budgeted margin. We, in fact, came in with arrearage less than that which was budgeted. Parishioners sent in pledge checks to the church and many of us used the online giving platform Tithe.ly, accessible from our church's website. Pledges and the mission plate were supported. We also received generous pledge donations from the previous year, 2019. This was most welcome, especially this year. Thank You!!!

Also, the diocese provided grants to parishes which was funded from the Paycheck Protection Program. We received \$9,949.40 from this program. This proved helpful in the middle of the year when things weren't looking up.

We received an unexpected and most generous gift which was directed to our endowments, \$38,000 to the Legacy Fund and \$38,000 to the John C Dirlam Fund. These gifts strengthen our endowments. The Dirlam Fund is restricted to the care and maintenance of our building. Every dollar in the Dirlam Fund generates interest income which is directed to the care of our church building. We are so grateful. We all look to take care of our church, our parish, now and in the future.

As you look to the financial reports that follow you will notice that balance of our bank account was \$92,517.00 at the start of the year and \$71,509.50 at the end of the year. This appears to be troubling. However, we did \$48,658.97 in repairs and maintenance to our building this year. This was deferred work that was well in need of being done. Please refer to the Building and Grounds report for details. But I can assure you that every penny was well spent. So almost \$50,000 was spent and our accounts were only down \$21,000.

I regret to inform you, that this, although this was my first year as treasurer, it will also be my last. I learned at least a couple of things this year. First, the job of Treasurer is extremely arduous. And second, I'm not the right person for the job.

I've only been able to get through this year with Susan Howland's and Chris Bolte's help, and with the emotional support of my wife, Sue. Without which I'd surely have drowned.

As I've moved into retirement, I assumed that I'd have more time to take on this task. Now I know why people retire, we have to. I made a list of things to do after I retired. Now I know I need to add another task, take naps.

In the future, my understanding is that the Treasurer's tasks will be divided between the Treasurer and the Chair of the Finance Committee. Please give them every support and consideration. Sometimes we say jobs like this are thankless, but even in my stumbling, I've felt the gratitude of everyone in the congregation and in parish leadership. Bless you all.
