ORGANIST/CHIOR DIRECTOR'S REPORT

Another year has come and gone and I thought by now we would be back to singing out hymns during the church service. The music had to change as we struggled with the virus as it completed its up and down cycles. I enjoy playing the organ and I love playing hymns, so I have searched for instrumental music that contained familiar hymns that many of us could recognize. So even though we couldn't sing them, we could enjoy listening to them.

This year has been a tough year for me as I recuperated from an operation in June. Thankfully, the tumor was benign, but the recovery time from the surgery took longer than I expected. I was able to return to playing the organ on August 22nd only to have 3 members of my family contract Covid 19 at the end of October causing me to miss more time at church.

Missing my time at church, as an organist, is always hard for me. I have not missed many Sunday mornings in all the years I have been a church musician. I went into the operation with some peace. I was scared, but I knew my family and I would face whatever the outcome. During my recovery, I prayed and thought carefully about my future and I came to the decision that, for a while, I could not play in church every Sunday and work full time at WPI. Since WPI would not allow me to go part time, I decided to spend one weekend a month to rest and spend time with my family. I plan the music for Sunday mornings on Wednesday nights. On Saturdays I practice for the church service and I spend 2-3 hours at the church. Sunday mornings I arrive at the church between 8:45-9:00 to prepare for the start of the service. When I am not playing, I will have that time to devote to my family and to rest.

Our church musicians have helped us during this time and thank you for the giving of your time. Please thank Joe DiSalvatore, Susan Howland, Lynn Garland, Jean Frost, John Grant, Lana Pieczynski, and Father Richard for their assistance. I appreciate the giving of your time and talent to fill in when I was away and to add to our service when I reach out to you.

Sadly, we ended the calendar year saying goodbye to Fr. Richard and Nina. Christmas Eve was a sad service for me as I said good-bye to my boss, spiritual mentor, and friend. I will miss Nina's singing in the choir and Fr. Richard's music selections.

DAUGHTERS OF THE KING REPORT

The one constant in life is said to be change. This certainly has been a year of change here at Holy Trinity Church. I think we have all felt the uncertainty in the changes both in our parish and in all things on a national and global level. It has been a year in seeking God's guidance and discerning through prayer where the Lord is leading us and what He is calling us to do.

The Daughters of the King are charged with our purpose in prayer and mission. We maintain a prayer list, which we pray daily, petitioning for the healing, guidance, and special concerns of our parish, country and world, in addition to praying for the departed and mourning of our parish.

The "Daughters" are also members of the Mission and Outreach Committee. We continue to focus on ministry by identifying eligible charities to be recipients of our mission plate donations. We identify charities on local, national, and international levels which we feel reflect the overall mission of our church. We thank everyone who has donated to our

mission plate over the past year. Every donation matters, as it empowers us as a parish to better the lives of those in need.

In 2020, the "Daughters" initiated a new "companion relationship" with the Sons and Daughters of the King (SDOK) in Buchanan, Grand Bassa County, Liberia. Back then, it was our goal to establish a ministry of prayer and aid focused on providing essential supplies for the children of Liberia.

This past year, we have developed and deepened that companion relationship and ministry of prayer and aid. Our companion relationship with the SDOK in Liberia started out as "a getting to know you" and "fact -finding experience", via Zoom meetings. We have come such a long way since those initial meetings.

The highlight of this year was on August 15th when Julia Duncan-Cassell came to visit us here at Holy Trinity Church. Julia is a member of the Episcopal Church in Buchanan, Liberia and is president of her local chapter of the SDOK. Julia, through her presentation, gave us a first-hand account of the plight of the Liberian children, especially the girls. She also spoke about the devastating effects of the pandemic on the people of this poor nation. Seeing her photos of the children, especially the young girls and hearing her testimony of how the Episcopal Church, through their schools and ministry is providing a safe haven for them, in a country torn by poverty and violence, was very impactful in our call to aid in this important ministry.

Our mission of aid continues to provide critically needed children's clothing, school supplies, toiletries and P.P.E. (face masks, bleach, disinfectants wipes, etc.). Monetary donations are vital in funding the shipping costs of these supplies to Liberia. In 2021, through the generosity of our parishioners, we filled four large barrels and a tote full of essential supplies and donated \$625.00 for the shipping costs to some of the most needy children and families in Liberia.

The need is real and on-going. The pandemic has only exacerbated the poverty and devastation in Liberia. Every item that is donated and every barrel that is shipped, makes a significant difference for the children who have so little.

I end my report with a note of heartfelt thanks to all those who have supported these ministries through prayers and donations. It matters! Matthew 25-40 states: "I tell you the truth, whatever you did for one of the least of these brothers of mine, you did for me."

The family lives in a house made of mud and sticks with a corrugated metal roof. They get water from a rain catchment in the yard, and they share a latrine with neighbors. They are Christian and speak Luo. Nicholas walks 45 minutes to school and for health

care. His favorite subject is Math.

My primary work as Jr. Warden had been to keep an eye on Communications, which I continued in 2021 (see Website and Communications report). But, with Fr. Richard's retirement announcement, the warden's role became more day-to-day with added responsibility.

Lynn and I worked as a team on a 6-month plan to facilitate a smooth transition and a joyous farewell celebration for Fr. Richard. This could not have been accomplished without the solid support of the executive committee, the vestry and the whole parish, and I am endlessly grateful for this support! The Farewell celebration for Fr. Richard and Nina on December 5th was elegantly and efficiently organized by a small group of parishioners. Sixty people, including most of our children, gathered in-person for the first time in almost 2 years to say good-bye.

I am looking forward to this new "chapter" at Holy Trinity with Mother Judith Lee, the vestry, our parishioners, and whoever God brings through our doors.

ADMINISTRATIVE AND BUILLDING

BUILDING AND GROUNDS REPORT

2021 found the Building Committee, Fr Richard, The Executive Team and Vestry using email and text to communicate allowing navigation of building issues both routine and challenged.

On behalf of the leadership, parishioners and staff we heartily thank all that in 2021, contributed: time, energy, effort, resources and finances to the building we warmly refer to as Holy Trinity Church; because of you the building continues to house our services, mission and outreach. This includes a small but very dedicated group who mow the grass, cut back bushes, rake leaves and keep weeds at bay, as well as plant flowering plants periodically throughout the year.

What follows is a summary of the monthly Building Committee reports to the vestry. Several major projects were undertaken some by choice some by necessity. Numerous small and not so small tasks were taken on by Sexton Greg Nikolla, our trusty handy man Brian Canty and various parishioners. All done in a timely and "in their stride" manner.

It is worth noting that despite considerable heavy rain periodically throughout the year the building committee are happy to report that there appears to have been NO leaks into the building at all. It seems that the repairs done in 2019 and 2020 took care of the leaks... we remain, of course, with fingers crossed and continued prayer.

To start, some small but very significant tasks:

Securing a new cover for the drain outside the undercroft entrance door took some doing, not a stock item and needing to be metal not plastic, it had to be custom made by a blacksmith. The original drain cover had rusted through in several spots, was allowing debris to enter the drain pipe and was a trip hazard.

New emergency light fixtures were purchased for the parish hall. Greg arranged for them to be professionally installed at no charge.

The boiler annual insurance inspections took place in February. No issues were identified but work to a rusted pipe was recommended. Although the building committee agreed to do this work in the off season it was overlooked. This will be rectified early in 2022.

The annual cleaning of both boilers and checking the steam heating system took place in October. No issues were identified and the heating systems worked without too many hiccups both at the beginning of the year and at the end of the year.

The annual fire extinguisher inspection took place twice in 2021. The first, was a Covid 19 delayed 2020 inspection. A leaking 30-year-old extinguisher was replaced. The 2021 inspection in November put us back on our normal annual inspection schedule.

We passed the semiannual Food Service Inspection in May and the annual Food Service Inspection in November with flying colors. After petitioning the Board of Health, Holy Trinity was granted a fee exemption.

Due to Covid 19, building use restrictions remain in place, with the result that less trash is being generated. We contracted with our waste disposal company for a smaller trash barrel which has saved us a small amount of money. It is just fine for our current needs.

Major sorting out of family worship resources took place and items to be stored were moved from the parish hall to the undercroft, then to a classroom. Discussion continues regarding where and how they will eventually be stored.

Holy Trinity received a donation of all the necessary equipment to install WiFi to the lower level. WiFi was successfully installed in the undercroft, installation to the classrooms is at the discretion of those doing the installation.

On behalf of the parish Tamsin Lucey met with our new neighbors at 448 Hamilton St.

2 New dehumidifiers were purchased 1 was a replacement and 1 to be used to address concern for mold and mildew in the stairwell to the lower level.

Greg Nikolla continues to do an excellent job as sexton completing all the regular cleaning duties and other items in his job description with due diligence and good cheer. To list a few other items, Greg: installs and removes the window A/C unit in the office; installs, empties daily/as needed 5 dehumidifiers that help keep the stairwell and lower-level mildew/mold free; encounters bats in the church and parish hall at least 2 or 3 times a year; sprays for ants wherever

they turn up; cuts down brush and weeds at the bottom of the fire escape so that parishioners have a fighting chance of keeping them under control. Greg was able to take his annual time off carried over from 2020 and for 2021.

Greg remained responsible for snow clearance through the 2020/2021 winter season and he accepted the position of snow clearance for the 2021/2022 winter season.

Three rather involved projects were undertaken in 2021:

To provide a dedicated space for the Coat Closet, renovation of the largest storage area in the undercroft were undertaken: removal of old drop ceiling tiles, cleaning and painting the ceiling grid, purchasing and installing new ceiling tiles, repairing walls, installing base board, constructing shelves, cleaning and painting walls and trim, and installing hanging racks. This work was carried out over a period of at least 8 months with materials and time being donated by parishioners. The Coat Closet have expressed their thanks.

The railings for the handicap ramp needed to be replaced. This project proved to be quite tedious and took several months. It was finally completed in November. Thanks go to a teen parishioner's girl scout troop for removing the old railings and to a parishioner for taking away all the debris.

Repairs to the cement stairs to the undercroft entrance were undertaken and completed just before the winter. The hand rail will be installed before the annual building inspection in January. We were advised by the building contractor to use a smart melt with calcium chloride pellets ice/snow melt on the concrete walk ways NOT sand and salt.

The 2021 annual building and fire inspections required several projects to be undertaken before the 2022 building and fire inspections. The following were duly completed:

Installing a commercial self-closing door mechanism on the fire exit door at the end of the classroom hallway. Done at no cost.

Replacing the concrete "pad" outside the fire exit door in the undercroft hallway.

All the external doors be numbered both inside and out and a chart submitted to the Fire Department for reference purposes.

All the emergency light units to be noted on a chart and a log maintained with date of installation date battery changed, and date each unit is tested.

A copy of the fire system annual test report was furnished to the Fire Department.

The Building Inspector requires a fire escape inspection once every five years for the stairs from the parish hall. This was not previously required. Various local structural engineers, Church Insurance, and the Building Inspector were contacted none were able to furnish an inspection report. We refer back to the Building Inspector for a recommendation of where to find someone prepared to do the inspection.

WEBSITE AND COMMUNICATIONS REPORT



Holy Trinity's investment in on-line communication continued to be critical in 2021. Even when we returned to inperson services some committees continued to meet by Zoom We purchased a "streaming" laptop and returned Fr. Richards office laptop and resumed streaming to Facebook Live in October even though we were worshiping in person. It has been a challenge to keep abreast of copyright law, and the changing requirements for streaming the liturgy and music.

Internet connections are always subject to disruption, but our switch to Spectrum Cable has increased our internet speed and the Audio and Visual experience on Facebook Live and Zoom is fairly reliable.

The diocese offered a grant of up to \$2,000 for technology expense incurred to stream the service and conduct virtual meetings. An application was submitted in 2021 and we received the \$2,000, which has been put in reserve for future technology needs.

The website is now under revision and when Mother Judith arrives expect to see some changes. The recording of the service is regularly made available on our Facebook page, and on our website.

The MailChimp E-Newletter continues to be a good resource for reaching parishioners. We still send postal mail to those who do not have email.

As the communications "point-person" I have attempted to keep leaders connected and the information flowing especially after Chris Bolte's resignation and Fr. Richard's retirement on 12/31/21. Emily Thompson has done a great job as our interim secretary working with the various people involved with ministry at Holy Trinity.

FINANCE COMMITTEE REPORT

The mission and purpose of the Finance Committee is to serve as stewards of the financial resources of the parish. While the Vestry has ultimate responsibility for all the resources of the parish, the Finance Committee can share this responsibility, and that of the treasurer, by bringing its knowledge and experience to bear on parish financial matters.

The Finance Committee is a Committee of advice to the Vestry. The Vestry approves its members.

The responsibilities of the Finance Committee are to provide the Treasurer with a group of thoughtful, committed members of the parish with whom the treasurer can discuss ideas and parish financial matters, and assist in the development of the annual parish budget.

The Finance Committee met three times by Zoom in 2021 and shared emails for further discussion. In July our parish secretary, who was doing the bookkeeping, resigned. To assist the treasurer and for best financial practices and separation of duties, members of the finance committee took over some "bookkeeping" responsibilities, providing oversight for transfers, 2nd signature on purchase orders and bank reconciliations.

A draft budget was presented to the vestry in October. By the time the majority of the pledge cards were received we did not have a significant deficit and resolved to budget reserve funds for a balanced budget. But, in December we were able to balance the budget without using any reserve.

I am grateful for our dedicated treasurer and dedicated finance committee: Nancy Waugh, Peg Nelson, and Josh Spooner We also are grateful for the work of our long-time pledge secretary, Mick Kalber, our bookkeeper, Chris Bolte, for $\frac{1}{2}$ of 2021 and for Nancy Waugh who as treasurer took over the bookkeeping.

As always, we pray for the needs and ongoing work of the church and ask for your prayers as well

TREASURER'S REPORT

I started as treasurer in February and with the resignation of Chris Bolte in June I assumed the additional bookkeeping duties.

In a year when there could have been unfulfilled pledges with the economy affected by Covid the pledges were on budget. Thank you to all for making your pledging to Holy Trinity a priority.

The total income vs budget was underbudget by \$10,585. The following are explanations of the income lines:

- We had budgeted for an unfilled pledge of \$5,400 with pledges being fulfilled this line was underbudget.
- We received pledges for the prior year of \$4,371 and this is not budgeted.
- The trust funds earned \$521 more in interest income than budgeted.

The expenses were over budget \$1,690. The following are explanations of some of the budget lines:

- There was a gas bill from December 2020 paid in January 2021 because the bill was not received for \$94.
- The electric was overbudget \$528 and it is thought that the dehumidifiers caused a spike in usage during the summer.
- Hospitality was over budget due to our catered farewell lunch for Fr. Richard.
- Capital improvement was overbudget due to the replacement of the handicap railings expense of \$13,350.
- Staff expenses were underbudget with the reduction of hours of the secretary and organist have resulted \$3,175 underbudget.
- The repair to the undercroft stairs was completed January so the invoice will be paid in 2022.

Thank you to the finance committee for their support during this first year as treasurer.
